Official Information Act request relating to information held by the Prime Minister's Office on Tui Taurua Peihopa, Jak Wild, and Victoria Roberts

Thank you for your Official Information Act 1982 (the Act) request, received on 2 October 2019. I note that you have requested (in relation to letters within and referred to in an OIA release by the Ministry of Health on the FYI website¹):

"We request all information you hold regarding these letters and any information you hold regarding the individuals named in this request, particularly the ones who signed the letters - Tui Taurua Peihopa, Jak Wild and Victoria Roberts.

[...]

We request a copy of the letter you actually received and all information you and your offices hold regarding this matter."

I am refusing the part of your request for a copy of the letter given to the Prime Minister, Rt Hon Jacinda Ardern in Waitangi on 6 February 2018 under section 18(e) of the Act as the document alleged to contain the information requested does not exist or, despite reasonable efforts to locate it, cannot be found.

Four documents have been identified within the scope of your request. Please find enclosed the following documents:

In addition, information not relevant to your request has been removed from documents listed in the above table.

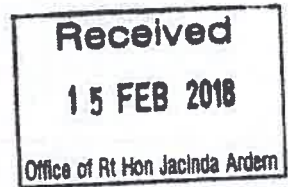
In making my decision, I have considered the public interest considerations in section 9(1) of the Act.

Dear Prime Minister,

By way of introduction, I have a number of designated Mental Health roles that carry the voice of Maori Tangata Whaiora. These roles include several Iwi that mandate my mahi (Ngā Puhi, Tainui, Tuhoē, Ngāti Porou), and representative roles with national service user groups, Te Huarahi o te Kete Pounamu (National Maori Mental Health Service User Roopu) and Ngā Hau E Whā (National General Mental Health Service User Roopu).

We, myself Tangata Whaiora Tui Taurua-Peihopa, Kaumatua Tangata Whaiora Kingi Taurua and Tangata Whaiora Jak Wild led a three day Te Tai Tokerau Mental Health hui on Te Tii Marae, Waitangi during the recent Waitangi celebrations.

The hui was a significant collaborative event, being hosted by Ngā Puhi, facilitated by Ngā Hau E Whā, with assistance from Frozen Funds Trust.

The attendees included numerous Kaumatua from across Aotearoa, and from local hapu and Ngā Puhi leaders.

The strong interest in the topic created robust debate, where people talked openly and

honestly, sharing their own, and their whanau's lived experiences.

A number of resolutions were agreed on during the hui:

- 1) A mandate for Tui Taurua-Peihopa to be the Tangata Whaiora voice for Ngā Puhi, Tainui, Tuhoe and Ngāti Porou.
- 2) For Ngā Puhi to endorse the Ngā Hau E Whā drafted letter (you received by hand on 6th February), and to support my hand delivery of the letter to you whilst you attended Waitangi celebrations on the Treaty Grounds.

Unfortunately, I was unable to make direct contact with you on behalf of Ngā Puhi whilst you attended on the Treaty Grounds, but fortunately my colleague Jak Wild was able to hand deliver to you the Ngā Hau E Whā letter and register of the Waitangi hui attendees that endorsed the letter. Please note, the attendance registration sheets you received, had only 25 of the 60+ hui signatories that endorsed the Ngā Hau E Whā letter.

By way of a follow up to the Waitangi Mental Health event, I would like an opportunity to meet with you one-on-one, except for my official photographer, Sarah Cordery who I would like to also attend.

The purpose of this hui would be for:

- Maori Tangata Whaiora to have an opportunity to commend your Government's recent Mental Health initiatives.
- For you to hear directly the voice of the Maori Tangata Whaiora leadership, and acknowledge its importance to your Government's initiatives.
- To explore opportunities for closer collaboration and commitment between your Government and Tangata Whaiora representatives.

May I suggest we have a two-hour hui sometime within the next 6 weeks.

I propose we meet confidentially, with a mutual agreement as to what is publically reported on as a result of our hui. That we identify a convenient and appropriate location and venue for our hui. My preference would be to meet privately at Te Tii Marae, Waitangi, but a location in Wellington may be logistically more convenient for you.

I have included here the Panui that was used to promote the three day Tangata Whaiora Hui at Waitangi, 4th, 5th and 6th February 2018 and a copy of my profile from the "100 Maori Leader's" Website < <https://100maorileaders.com> >.

I look forward to your reply and am hopeful that a new dawn is on the horizon for my fellow Maori Tangata Whaiora and their whanau.

The waiata of Tui

I can't remember when I first met Tui. I know it was a long time ago. She stood out, she stands out as a reflection, as a culmination of all that once was. Her spirit is so decisively poised within the body of self. The self seen, yet her full self not known.

I wondered who this striking woman was? She spoke from the heart about her experiences as a crazy person locked up. A Ngāpuhi, a wahine, a daughter, a human being that was being treated in a non-human way. I remember thinking as she opened up, that it sounded like a place that was foreign, stark and unforgiving. The descriptions, the details too terrifying to recall, but when the glass ceiling shattered, the voice emerged.

Tui Taurua is the quintessential leader of the tangata whāiora movement. I dare not attempt to detail the number of kaupapa that she has led or contributed to, but I can and must talk of one. Following the recommendations of the Mason Report, the *Like Minds, Like Mine* programme was established. The initiative led by Gerard Vaughan focused on reducing stigma and discrimination of people with mental illness.

It was a ground-breaking initiative, which challenged people to confront their biases, challenge their ignorance and sought to address their prejudices of a people with lived experience. Tui was a major influence in the development of the campaign having worked tirelessly to ensure that the kaupapa was tika and that Māori were central to the dialogue and the delivery.

Leadership as I see it with Tui, is bound in her story, in her Ngāpuhitanga and in her womanhood as wahine Māori, as tangata whenua. She is courageous, relentless and provocative. Falling for Tui is striking. Shining in the context of lifting the veil on the unseen, on and in the depths of madness. A madness that is never expressed as an is, but as it is.

- Mental distress, mental health, mental illness, psychological trauma, madness, psychiatric disorder etc.
- Tangata whaiora (personal lived experience), tangata motuhake (people who live in self-determination), a consumer, a service user, a psychiatric survivor, etc.
- Any specific diagnostic term such as; acquired brain trauma, addiction, autism, bi-polar, co-existing disorders, schizophrenia etc.

- ✓ Supporting management and ability for change
- ✓ Workforce development including the peer workforce
- ✓ Improved outcomes for Maori

Thank you for your prompt and diligent attention to this matter, it is much appreciated, particularly as the actions of the three people from NHEW who signed the letters are directly hindering and preventing us from finalising our submissions to the Mental Health Inquiry - we have requested an extension but are required to state how long the extension is to be - which depends on how long it takes to receive information we have requested from the Ministry of Health and other related matters.

Dun Mihaka and I, and others, do indeed challenge the statements made in the letter from Tui Taurua. We have engaged in communication with Ms Taurua regarding these matters, and a transcript of emails to and from Tui Taurua, Victoria Roberts and Jak Wild is attached. As you can see, these communications do not stand up to scrutiny! We have other information which evidences the fact that the signatories intention was to share our information WITH EACH OTHER for the stated purposes of establishing a support network, and it is vitally important that we obtain access to the information immediately because over four months have been wasted already and people are in dire need of support!

We (Dun Mihaka and Katherine Raue and another of the persons who were delegated and mandated to speak on behalf of the attendees of the hui at Te Tii Marae) request a meeting with a suitable representative of the Prime Minister and the Minister of Health as soon as possible to discuss these matters and discuss recent decisions of the Privacy Commissioner which also do not stand up to scrutiny - we should not have to file action in Court to access our basic human rights and our own information, and a copy of a document we signed which is being grossly misused.

Thank you for your attention to these matters, it is much appreciated.

Kia ora Katherine,

Thank you for forwarding to me the email you sent to the PM, Jacinda Ardern and Minister Andrew Little.

I have done a bit of investigating and I've uncovered the following:

- 1) We have no record in this office of the hand delivered letter from Waitangi which apparently had a list of attendees attached.

- 2) We have though receipt of the email from Tui Taurau on 15 February which you also sent through as a scan yesterday. This email from Tui Taurau - Peihopa which as you know requested a two hour hui was logged as a meeting request – there was no attendance list attached in the email. Just recently it was forwarded to the Minister of Health to ask if we could refer the request to him, as Mental Health issues fall under his portfolio. As I said this request did not have a list of the attendees attached, although I note in the letter that Tui Taurua-Peihopa has said that at the hui at Waitangi a number of resolutions were agreed on, one being that it was agreed that Tui Taurua- Peihopa was to be the Tangata Whaiora voice for Nga Puhi, Tainui, Tuhoe and Ngati Porou.

So Katherine, it seems we do not have in our possession a list of attendees from that Hui in Waitangi. However if you feel that in his email, even this sentence that:

"Tui Taurua- Peihopa was to be the Tangata Whaiora voice for Nga Puhi, Tainui, Tuhoe and Ngati Porou"

is not what was agreed on I suggest you let me know and I will then follow up and advise the Minister of Health's office that there has been a challenge to the facts stipulated in email request for the hui. I am presuming Katherine, there has been some dialogue with Tui Taurua- Peihopa already to advise him or her that you have contacted our office on behalf of yourself and other's to challenge the contents of the letter and email?

By the way, I have also approached the office of Minister Andrew Little and they have told me they have no record of the email or letter on their systems.

Tēnā korua Jacinda Adern and Andrew Little,

We write to you in your capacity as Prime Minister and Minister for Treaty Relations regarding the two letters attached.

The letter signed by Jak Wild and Victoria Roberts was apparently hand delivered to Jacinda Adern at Waitangi on or about the 6th February 2018, and the second letter which is signed by Tui Taurua was apparently sent to Jacinda Adern on 15 February 2018.

We are two of the persons who signed the "register of the Waitangi hui attendees that **[allegedly] endorsed the letter**" which is referred to in the paragraph beginning with the word "Unfortunately" on the second page of the letter dated 15 February 2018, and I can tell you that **we did NOT, and DO NOT endorse either of these letters, and we are most concerned indeed at the manner in which the document bearing our signatures has been used,** and so are others who were at the hui!

The attendees at the hui were unaware of these letters. We have been requesting "the attendance sheets you received" from the organisation Nga Hau E Wha who claim ownership of them, after falsely telling us they "belonged to Ngapuhi" initially - prior to changing their mind and telling us that they are owned by Nga Hau E Wha.

The claims made in these letters are simply untrue!

We request these "attendance sheets" without delay! The intention of the persons who signed the document was to establish our own database to connect us with each other, with whanau, not to give our personal information to this organisation Nga Hau E Wha so they could control it and use it for their own purposes! This was the understanding on which we signed - NOT to endorse these letters! That is confirmed by the panui regarding the hui and the evidence of the many witnesses who are becoming increasingly angry at being misrepresented and refused access to our own information! The mandate claimed is NOT the mandate that was given! There are a number of witnesses to this and a growing number of people who share our concerns about being misrepresented like this - Nga Hau E Wha have NO mandate to speak for us and we wish the opportunity to speak for ourselves and be heard - rather than used to facilitate a photo op for you and Tui Taurua and her "official photographer".

Has there been any response whatsoever from the Prime Minister or anyone else to these two letters?

If so please provide it without delay, along with all other information regarding this matter including details of any scheduled meeting, any other correspondence, etc.

I represent a significant number of people who signed a **petition calling for a judicial inquiry** into matters associated with these letters, and I write on behalf of another person who was mandated by the kaumatua and kuia of Ngapuhi, at Te Tii at this hui, regarding this kaupapa, and several of the signatories of the "attendance sheets" and we respectfully request a meeting with you, or anyone who is dealing with this matter in your imminent absence, URGENTLY regarding these letters.
