Request under the Official Information Act 1982

I refer to your refined request made to the Department of Prime Minister and Cabinet on 20 March 2020 under the Official Information Act 1982 (the Act). On 3 April, parts of your request were transferred to me given the close alignment with the functions of my portfolio as the Minister for Māori Crown Relations: Te Arawhiti.

You requested the following information:

- (a) all Cabinet papers since 2005 which discuss the constitutional status of the Treaty of Waitangi:
- (b) all Cabinet papers relating to the foreshore and seabed act 2004; and
- (c) all Cabinet papers relating to the establishment of the Māori-Crown portfolio.
