

The side of the vehicle that spark was scene on still exhibited paint to the body of the vehicle. There were glass bulbs still remaining in the front of the vehicle. Given all of the above fire patterns the fire reigniting inside the vehicle was discounted as the ignition source. Other ignition sources were canvassed reported that may have left a bedside lamp on next to a small bottom bunk bed inside the garage. This was an approximately \$10.00 bedside lamp. One lamp that looked like the one beside the bed was located in that area, however, could not be sure if it was the kitchen light as it was of similar design to the lamp. This lamp located did not exhibited enough fire damage to be the ignition source. However, it may not have been the bedside lamp that may have been left on. Therefore, the bedside lamp could not be completely discounted as the ignition source.
