#### Official information request regarding disabled students at VUW Law School

I refer to your request for information under the Official Information Act 1982 (the Act) dated 28 March 2021:

- 1. What percentage of students in Laws121 self-identified as having a disability over the past five years?
- 2. What percentage of students in Laws121 were enrolled in disability services over the past five years?
- 3. What percentage of graduates of law self-identified as having a disability over the past five years?
- 4. What percentage of graduates of law were enrolled in disability services over the past five years?
- 5. What percentage of people enrolled in laws 121 graduate with an LLB, over the last five years?
- 6. How many students over the past five years have been granted extensions for assignments in a compulsory law course (Laws121, Laws122, Laws123, Laws211, Laws214, Laws213, Laws 212, Laws301)?
- 7. How many students over the past five years have been granted special assessment conditions in Laws121 and Laws301?
- 8. What is the percentage of students in Laws301 who self-identify as having a disability over the past five years?
- 9. What is the percentage of students in Laws301 who are enrolled in disability services over the past five years?
- 10. What percentage of Law Honours students have identified as having a disability over the past five years?
- 11. What percentage of Law Honours students are enrolled with disability services over the past five years?

# 1. What percentage of students in Laws121 self-identified as having a disability over the past five years?

Please note, the Bachelor of Laws (LLB) is a four-year degree. However most students take it as part of a conjoint degree which usually requires 5-6 years of study. We have provided data from 2010 onwards as most students who enrolled in LAWS 121 in the last five years will not have completed their requirements.

This data includes all students enrolled in LAWS 121, not just those taking it for the LLB. Therefore, some students may be taking it to count towards another qualification. The data does not include information on whether students went on to graduate with another degree. Due to the varying timeframes of the degree, students do not graduate as a cohort relative to their initial year of enrolment. Additionally, some students may enrol in LAWS 121 more than once in order to obtain the grade required for selection to second year LAWS courses.
