

On 20 July 2017, you emailed my Office requesting, under the Official Information Act 1982 (the Act), the following information:

 A list of all aide memoir, cabinet papers, briefing papers and weekly reports received by the Minister in her role as the Minister of Children and the Minister of Social Development between the period of May 4 and July 20 2017.

The list enclosed includes the titles of reports provided to me in my capacity as Minister for Children and Social Development in the period from 4 May 2017 and 20 July 2017.

Please note that some titles are withheld under section 9(2)(f)(iv) of the Act as the information contained is under active consideration. The release of this information is likely to prejudice the ability of government to consider advice and the wider public interest of effective government would not be served.

One title has been partially withheld under section 9(2)(c) of the Act as the release of this information is likely to prejudice the measures protecting the health or safety of members of the public.

Some information is also withheld under sections 9(2)(i) and 9(2)(j) of the Act to enable the Ministry to carry on, without prejudice or disadvantage, negotiations (including commercial and industrial negotiations). The greater public interest is in ensuring that government agencies can continue to negotiate without prejudice.

Some titles of Aide Memoire are withheld under section 9(2)(g)(i) of the Act to protect the effective conduct of public affairs through the free and frank expression of opinions. I believe the greater public interest is in the ability of individuals to express opinions in the course of their duty.
