 unreasonably to prejudice the commercial position of the person who supplied or who is the
 subject of the information;
- 9(2)(f)(iv) to maintain the constitutional conventions for the time being which protect the confidentiality of advice tendered by Ministers of the Crown and officials;
- 9(2)(i) to enable a Minister of the Crown or any department or organisation holding the information to carry out, without prejudice or disadvantage, commercial activities;
- 9(2)(j) to enable a Minister of the Crown or any department or organisation holding the information to carry on, without prejudice or disadvantage, negotiations (including commercial and industrial negotiations); and
- 18(d) that the information requested is or will soon be publicly available.

One title has been released with information withheld under section 9(2)(a) of the Act to protect the privacy of an individual.

In making my decision, I have weighed up the public interest considerations in section 9(1) of the Act, and consider there are no countervailing public interest considerations that justify the release of this information.
