Paul Tomlinson's career with Corrections began as a probation officer in September 1978 and from this role he progressed through leadership opportunities in the North and South Islands. Paul's last role was Lower North Regional Commissioner. He was responsible for around 2,500 staff based in the region. Within the region there are nearly 30 Community Corrections (probation) sites, as well as four men's prisons and one women's prison. Paul retired from Corrections in 2019, after 41 years of service.
