#### AUCKLAND EVENT UPDATE:

To help with your planning, here are a few important updates:

#### END LOCATION:

Victoria Park (we will not be walking back across the Auckland Harbour Bridge). At Victoria Park, we will enjoy a couple of great speakers and some live music. We will also outline what is next planned.

#### TRANSPORT:

We encourage one driver from each family/group to travel back to Onepoto Domain to collect your vehicle and then retrieve your passengers from Victoria Park. We will set up a gathering point so drivers can work together to get back across the bridge. Here's a few ideas to help with this:

**UBER:** Drivers can carpool and call an uber to take them back to the North Shore

**BUS:** Auckland Transport have Bus 923 from Bus Stop 7036 on Fanshawe Street (right next to Victoria Park), that will take you direct to Stop 4046 on Sylvan Avenue, by Onepoto Domain. Please note this will cost approx \$3.51 and you will need to have a HOP card and adhere to their public transport rules.

Alternatively, we could just look after each other. If you are a kind soul with a bus or van, perhaps you might like to shuttle drivers back to the North Shore for free. Let us know below if you're keen to lend a hand with this.

#### WEATHER:

We'd encourage march participants to please bring sunscreen, hats and umbrellas to keep the sun off you as you march.

#### CHILDREN:

Parents, we'd kindly ask that you keep your children with you at all times during this march.

The safety of all customers is our priority. We do not support any access to the Auckland Harbour Bridge as part of protester actions. While it should be clear to all, an occupation or march involving the Auckland Harbour Bridge would unnecessarily expose individuals to health and safety risks, as well as major operational disruption to the integrity of the state highway network and Auckland as a whole.

Protest organisers have posted an update on social media (attached for your reference) that the planned activity is a march across the bridge, but we feel the risk of more extreme elements of the march deciding to stay on the bridge is concerning.

Could I request you please also include s9(2)(g)(ii) [asm.nzta.govt.nz](mailto:asm.nzta.govt.nz) in any upcoming operational or planning meetings (as appropriate) as he will be leading the operation planning for the Auckland Harbour Bridge for Waka Kotahi ASM.

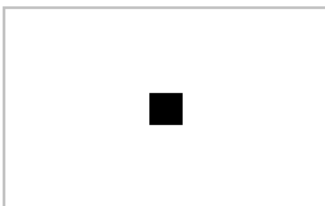

To Whom It May Concern

The Freedoms & Rights Coalition team wish to advise the NZ Police that we will be exercising our legal right to protest this Saturday, 26<sup>th</sup> February 2022, where we will be walking across the Auckland Harbour Bridge.

Many hikois over the years have been allowed to cross the Auckland Harbour Bridge. Our hikois should be treated no differently.

We will be assembling all protestors at 11am at Onepoto Domain on the North Shore, from where we will proceed to walk onto Sylvan Ave, then Onewa Road, and onto the motorway. The march will end at Victoria Park. We will not be walking back across the bridge. Attending Drivers will either catch public transport or Uber back to their vehicles on the North Shore.

As we walk over the Auckland Harbour Bridge we plan to occupy the two lanes on the far left-hand side.

We have some of our own security who will help to undertake traffic management during this march.

Given that the NZ Police have often charged any perceived 'organisers' at previous events we have arranged, there is an unwillingness from any individual within our organisation to want to engage with the NZ Police. This breakdown in communication is the fault of NZ Police and their continued inability to manage protest action effectively and proactively.

We are happy to engage via email, but we will not be giving the NZ Police any individual's

names or phone numbers.

Dear Shanan, Jill and Naila

Further to my letter of 17 February, I note the announcement by protestors in Auckland that they intend to march across the Harbour Bridge this Saturday and, from March 1 onwards undertake “mass rolling non-compliance actions... which will impact most New Zealanders.”

I support the right to protest peacefully and lawfully as a fundamental democratic right but draw the line when any protestors act as if they are above the law and wilfully disrupt the right of others to go about their lives.

I would like to reiterate Council’s support for any enforcement action you may deem necessary to minimise disruption to Aucklanders’ daily lives by any such protests and appreciate the good liaison and working relation Council officers have with NZ Police.

Council staff have worked closely with Police around the enforcement of bylaws which protect our public spaces and parks, and they continue to make themselves available to Police should you require assistance. Auckland Transport will also work with Police and Waka Kotahi to minimise the potential disruption to the road and public transport networks by protests.

I am particularly concerned that protestors may seek to march on the bridge and use vehicles to block the harbour bridge lanes. I presume that there are contingency plans in place to deal with these tactics should they occur. What I want to ensure is that your partners are fully engaged with you in a planned response, in particular Council, Auckland Transport and Waka Kotahi.

I am conscious of public expectations that they are not constrained in going about their lives by a minority group who believe that they are above the law and that there are no consequences for illegal and disruptive behaviour on their part.

I fully support you in what is a difficult task and don’t presume to interfere in your independence to determine operational matters, but I will be expected as Mayor to have a position on what might eventuate and I want to express that in a way that is as supportive as possible.

I would appreciate you facilitating a discussion with Claudia Wyss, Director of Community Services, today so that Council can provide whatever support it is capable of in dealing with the planned disruption.

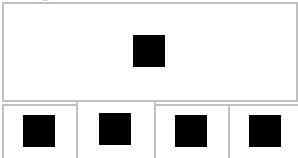

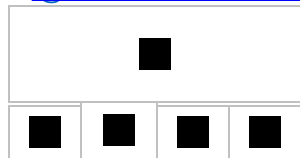

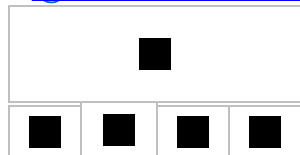

The ground for this operation will be the following locations:

### 1.1 Onepoto Domain

The Onepoto Domain is a large reserve at the base of Onewa Road alongside the Northern Motorway. Access is from Tarahanga Street and pedestrian access from Puawai Place, Sylvian Avenue and Exmouth Road.

### 1.2 Onewa Road On-ramp

The Onewa Road on-ramp is situated within walking distance of the Onepoto Domain. It is located at the bottom of Onewa Road adjacent to the Auckland Harbour HB Police complex.

### 1.3 Auckland Harbour Bridge

The Bridge is a prominent national landmark, an important part of Auckland's Road transport network as well as a structure to support critical infrastructure such as water supply, electricity and communications lines.

The road deck consists of eight traffic lanes separable by a movable concrete barrier, with critical infrastructure suspended beneath the deck.

### 1.4 Victoria Park

Victoria Park is situated adjacent to the Fanshaw Street motorway on and off ramps. A playground, accessible toilets, skate park, sports fields, picnic tables and seating, are inside the park.

### 1.5 March Route

The march route will be from the Onepoto Domain, Onewa on-ramp, southbound lanes on the clip-on, Fanshaw Street and Victoria Park.

### 1.6 Traffic Management Plan

There is a Traffic Management Plan (TMP) in place along the proposed march route.

## 2. SITUATION

### 2.1 General Outline

Destiny Church is part of 'The Freedoms and Rights Coalition' (TFRC) and are very experienced in organising protest events. Brian Tamaki is the leader of the church and has attended many of these events s9(2)(a)

On the 22<sup>nd</sup> February 2022, The Freedom and Rights Coalition posted on their website the intention to march at landmarks in five major cities, and that the Auckland march will feature the Auckland Harbour Bridge.

The march is part of the TFRC campaign to end Covid 19 related mandates by 1<sup>st</sup> March 2022 (Tuesday).

The Convoy 2022 protest in Wellington remains a significant venue of protest, with TFRC having pledged support to that event.

The possibility of a similar intention by some attendees has not been signalled but cannot be excluded.

**Recent Events:**

- On 5<sup>th</sup> February TFRC attracted 200-400 attendees at the Domain
- On 14<sup>th</sup> February at the Domain and in support of the Wellington Convoy, 7 people gathered near the cenotaph and waved flags. On the same day 40 persons also gathered at Western Springs to wave banners
- On the 17<sup>th</sup> February the TFRC posted on their site they intend to travel to Wellington to support the protest outside Parliament
- On 19<sup>th</sup> February the primary TFRC was travelling in support of Convoy 2022 to Wellington, however about 15 people gathered at the Auckland Domain

**2.2 COVID – 19**

At 11.59pm on the 2<sup>nd</sup> December 2021 the COVID-19 Public Health Response (Protection Framework) Order 2021 came into effect.

At 11.59pm on the 23<sup>rd</sup> January 2022 all of New Zealand moved to Covid Protection Framework level **RED** when the Government discovered nine linked cases of Omicron in the community without a link to the border.

The Ministry of Health is the lead agency for the COVID-19 response. Omicron as a variant is more transmissible with case numbers likely to double every 2 to 4 days and impact as large increases of infected persons (known as a spikes).

On 24<sup>th</sup> February at 23.59 New Zealand moved to phase 3 of the Omicron response framework.

At gatherings, other than at a home or dwelling, and if vaccine passes are used, up to 100 people based on a 1-metre physical spacing can attend.

If vaccination passes are not used, then any gathering is unable to operate beyond 25 people in a group with 1-metre spacings.



##### **Risks can be minimised through:**

- Being aware there may be delays in responding to emergency calls. Staff familiarising themselves with their assigned area(s) and roles
- Working within their group parameters and wearing PPE with the correct KN95/P2 masks and rubber gloves
- Staff having access to a radio with earpiece and a public safety 'mic' for NCOs
- Having available all standard safety equipment and high visibility event jerkins, especially when working on any road network
- Having appropriate uniform available for the weather conditions – i.e. wet weather gear/duty jacket/jersey
- Having wide brimmed hat available for sun protection
- Awareness of motorway speed traffic – this is significantly higher than urban

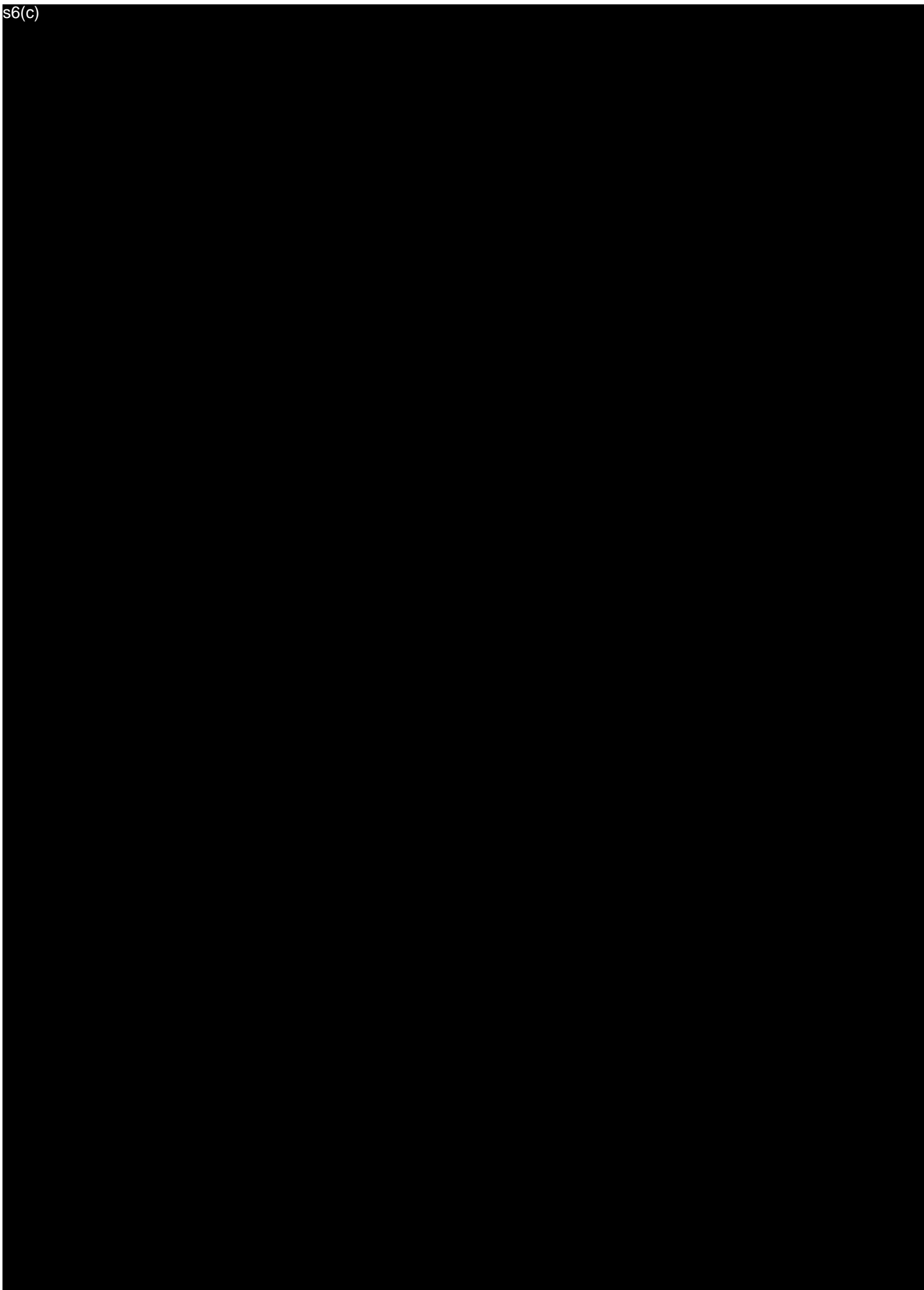
Tactical and operational decisions are to be made by police only, without influence or pressure from foreign officials. They are to be made and applied in a consistent and impartial manner, with police exercising restraint always.

Police need to be deployed in sufficient numbers to be able to be confident of remaining in control of any demonstrations arising from any COVID related enforcement, so as not to be forced into overly hasty actions.

New Zealand police officers have responsibility for policing a demonstration. Private Security Guards or Marshals should not be permitted to participate in policing the demonstration.

- Have an appreciation of all aspects of the operation and the roles that staff will undertake
- Seek the advice of health and safety subject matter experts where necessary
- Assess any work undertaken which could potentially expose staff or the public to any hazard or risk to health and safety
- Ensure awareness of any threats associated with this operation
- Ensure that safety due diligence is conducted over the course of the operation
- Ensure that as reasonably practicable, identifiable risks are eliminated, and where that is not possible, measures are put in place to minimise the risk to the lowest levels possible
- Advise District Wellness and Safety Advisor of any potential notifiable events (as per Health and Safety at Work Act definitions)
- Ensure safety briefings are undertaken by all staff and appropriate PPE clothing and equipment is available, and lessons learned are reported
- Monitor incident and near miss reporting
- Participate in planning meetings to highlight and give advice in relation to Health and Safety matters
- Ensure that key internal partners (operations command / DCC / north comms) are kept up to date and aware of the location(s) where staff are deployed, and any risk associated with the operation
- Participate in debriefs

- Supervise engagement teams targeting motivated person of interest
- Ensure operational communications are always maintained
- Provide staff with any up-to-date intel on possible issue that may affect the operation
- Ensure regular situation reports are given to the Operation and Forward Commanders
- To ensure as is reasonably practicable, identifiable risks are identified and eliminated, and where that is not possible, measures to minimize the risk to the lowest levels have been taken within the guidelines of the Police Health & Safety Policy
- Redeploy or respond as directed by Operation or Forward Commander
- Ensure any prosecution files (not protest organiser's) are completed before end of shift
- Participate in debriefs



## Role: PROTEST GROUP

### Function Description:

- To oversee the safety of public and police during the harbour bridge crossing

### Tasks:

- Ensure assigned staff are fully briefed and have the required operational equipment prior to deployment.
- Ensure all staff are fully briefed, equipped and enabled prior to deployment
- Ensure there are two Tactical response vehicles available, crewed and ensure staff are fully briefed, aware of their responsibilities and positioned where they can respond immediately if required
- Ensure all staff are aware of any threats associated with this operation
- Direct, control and co-ordinate all staff deployment to ensure an organised and professional approach
- Ensure operational communications are always maintained
- Provide staff with any up-to-date intel on possible issue that may affect the operation
- Ensure regular situation reports are given to the Operation and Forward Command
- To ensure as is reasonably practicable, identifiable risks are identified and eliminated, and where that is not possible, measures to minimize the risk to the lowest levels have been taken within the guidelines of the Police Health & Safety Policy
- Redeploy or respond as directed by Operation and/or Forward Command
- Provide sitreps to Operation Command
- Maintain an overall assessment of the march and respond as required
- Participate in debriefs
- Ensure staff are debriefed prior to stand-down

## Role: SECURITY GROUP

### Function Description:

- Responsible for maintaining bridge security

### Tasks:

- Ensure all staff are fully briefed, equipped and enabled prior to deployment
- Ensure all staff are aware of any threats associated with this operation
- Ensure group has a Tactical response vehicle available, crewed and ensure staff are fully briefed, aware of their responsibilities and positioned where they can respond immediately if required
- Ensure staff are placed on across the bridge to guard the accessways onto the gantry
- Ensure protesters don't interfere with the Bungy Jumping or Bridge Walk groups
- Direct, control and co-ordinate all arrest teams to ensure an organised and professional approach
- Ensure the effective transfer of detained persons from arrest teams to processing vehicles
- Ensure operational communications are always maintained
- Provide staff with any up-to-date intel on possible issue that may affect the operation
- Ensure regular situation reports are given to the Operation and Forward Commanders.
- To ensure as is reasonably practicable, identifiable risks are identified and eliminated, and where that is not possible, measures to minimize the risk to the lowest levels have been taken within the guidelines of the Police Health & Safety Policy
- Redeploy or respond as directed by Operation or Forward Commander.
- Participate in debriefs

## Role: INTELLIGENCE

### Function Description:

- Responsible for Supporting Operational teams with intel scanning and intel gathering

### Tasks:

- To scan and monitor collate intelligence associated with this operation
- To provide intel support as required
- Gathers intelligence on other groups associated or opposed to the event
- Hostile reconnaissance detection
- Provides any relevant updates to the Operation Commander from the ground for purposes of providing situational awareness
- Provides trends and forecasting insights to the Operation Commander

## Role: PHOTOGRAPHY

### Function Description:

- Document Evidential support of any potential prosecution

### Tasks:

- Responsible for operational assistance using photography resources
- Have an awareness of this operation
- Ensure a uniformed police escort is available while performing photography duties
- Document by video and stills as appropriate, all activities, police and otherwise, in the area deployed
- Works at the direction of the Forward Commander
- Gathers intelligence on groups associated or opposed to the event
- Assists the investigation team with evidence gathering
- Provide obtained documentation as soon as practicable after the operation to the Operation Commander or as requested
- Otherwise deploy as directed

## Role: ADMIN OFFICER (RIOD)

### Function Description:

- Responsible for RIOD log entries and CAD scanning or dispatches within operation areas

### Tasks:

- Facilitate responses as requested by Operation Command
- To monitor DAS positioning of deployed staff
- To set up and gain access to the log event updates. Refer to instruction guidelines [Click here](#)
- Maintain a log of events recorded in EMS RIOD site

## ROLE: MPES

### Function Description:

- Responsible for ongoing liaison with protestors and local Iwi

### Tasks:

- Liaise with protest organiser about areas of responsibility for negotiation and dialogue
- Outline police expectations and crowd risk mitigation
- Undertake negotiation and dialogue with any other assigned parties of interest
- Provide feedback and input to forward command
- Utilise the grid site map to guide responding staff to any incident in and around the protest area
- Undertake any other operational tasking given
- Redeploy to other location(s) as directed
- Participate in debriefs

## Role: AIR SUPPORT UNIT

### Function Description:

- Responsible for operational assistance using air support resources

### Tasks:

- Have an awareness of this operation as part of business as usual
- Provide an air support and surveillance capability if required
- Liaise with Operation and Forward Commanders when necessary
- To provide a downlink CCTV monitoring capability to Operation Commander during key events
- Advise Operation Commander of any incidents affecting or likely to affect the event
- To promptly deploy at the direction of Operation Command
- Participate in debriefs if deployed
- Ensure staff are debriefed prior to stand-down

## **Role: POLICE MARITIME UNIT (PMU)**

### **Function Description:**

- Responsible for operational assistance using Maritime support resources

### **Tasks:**

- Have an awareness of this operation as part of business as usual
- Provide Maritime support and surveillance capability beneath the Auckland Harbour Bridge
- Liaise with Operation and Forward Commanders when necessary
- Advise Operation Commander of any incidents affecting or likely to affect the event
- To promptly deploy at the direction of Operation Command
- Participate in debriefs

## **Role: PNT**

### **Function Description:**

- Responsible to liaise with protestor leaders to encourage a particular course of action

### **Tasks:**

- To Liaise with protest organisers to negotiate and mediate actions to ensure no undue conflict between the group, police and members of the public.
- Establish information on protest intentions and advise Operation Headquarters
- De-escalate any conflict through communication.
- Advise the protest group of police expectations around behaviour and what enforcement action will be taken if unlawful protest behaviour occurs.

## **Role: NORTHERN COMMUNICATIONS**

### **Function Description:**

- Responsible for coordination of calls for service and situational awareness

### **Tasks:**

- Monitor the event log created in the National RIOD EMS site for this operation
- Identify any events that may impact on the venues, and escalate through to operations command
- In the event of a major incident in or near the area of operation, immediately escalate to operations command to determine ownership and the co-ordination of policing that incident
- Direct any operation related media enquiries to the media group
- Keep operation command advised of any issues created by a CARD outage that could affect the operation

## **Role: TĀMAKI MAKAURAU DISTRICT COMMAND CENTRE**

### **Function Description:**

- Responsible for Operational Support of Event and TM Districts

### **Tasks:**

- Maintain an awareness of this operation as part of business as usual
- Co-ordinates the TMDCC and NCCC support to this operation as required
- Work with operation command regarding any call for service that may be connected to this operation
- Advise operation command about any unrelated incident of note that may affect the execution of this operation
- Facilitate responses as requested by operation command
- Activate the Escalation plan if directed.
- Direct any related media enquiries to operation command

## **Role:SEARCH AND RESCUE GROUP**

### **Function Description:**

- Responsible for operational assistance using SAR resources

### **Tasks:**

- Ensure all staff are fully briefed, equipped and enabled prior to deployment.
- Ensure all staff are aware of any threats and risks associated with this operation, including the sort of protest tactics that might be used
- Deploy as required as directed by the forward or operation commander
  - Respond to any situations at height utilising the Technical Rope Rescue Team
  - Ensure the safe extraction of the protesters once secured.
- Participate in debriefs

### 1. INTRODUCTION

This document outlines the procedures to be followed regarding Mass Arrest Process (MAP) for Operation Stop Delta 2021.

Operation commanders considering the use of MAP must additionally evaluate the risk of spreading Covid-19 between separated groups. This includes between different Police teams, protest groups and existing detainees in a custody unit. As such, variation of the process may be expected as described below. For example, it may be prudent to process and release detainees in a nearby suitable area rather than automatically transporting to a custody unit.

As such, a variation of the MAP may be expected as described below. For example, it may be prudent to process and release detainees in a nearby suitable area rather than automatically transporting to a custody unit.

### 2. PURPOSE

Use of the MAP enables Arresting Members, Supervisors, Processing Group staff and Custody Unit to efficiently process high volumes of Detainees in a safe and efficient manner while complying with lawful requirements and with Detainee Duty of Care requirements being forefront in mind. A swift, safe, and effective process will enable Arresting Officers and Prisoner Escorts the ability to return to the frontline without undue delay.

The appreciation process should carefully consider flexibility options while mitigating risk to staff from the spread of the COVID-19 Delta variant.

### 3. REQUIREMENTS

MAP in a Level 4 lockdown environment will operate only on the express authority of the Operation Commander and in conjunction with safe detainee management and adherence to the latest updates on Covid-19 recommendations.

Locations for processing areas may include (away from public view):

- SFP locations
- Large carparks
- ACU carpark

### 4. TASER

The Operation Commander must authorise Taser carriage for MAP Sergeants assigned to the operation. Carriage is restricted to the MAP designated Processing/Custody area and is not permitted in areas where Public Order Policing (POP) is occurring, this is in accordance with national POP Policy, [Link](#).

Taser requirements:

- The Operation Commander has approved Taser carriage to individual operators
- Those staff are qualified/certified to do so
- Carriage is restricted to the MAP Processing/Custody environment and is not permitted in areas where POP is occurring
- The use of is subject to the TENR appreciation process and not to simply enforce compliance
- A TOR is completed prior to the end of shift by the operator

**6. MAP PROCESSING - Overlay  
Arresting Officer/Escorts**

- Arrests will only be made at the direction of the Operation Commander or where their authority to do so has been provided; O/C Groups/Squads (Inspectors/Senior sergeants)
- Constables directed to make an arrest must confirm to the arrested person the reason for the arrest and provide Caution/Rights Advice
- Consideration must be given to detainees arrested in POP situations having been secured using steel cuffs/plastic cuffs (to the rear) and includes the use of 'Sleeping Dragon' devices. Apply TENR
- All detainees will be escorted by a minimum of two Constables from the arrest location to the MAP staging area
- OC arrest MUST remain with the detainee until approval is granted by the MAP Sergeant for them to return to the front line (Post Processing)



- OC arrest will receive Personal Protection Equipment (PPE) and ensure the detainee is suitably equipped
- Utilise the Voice Memo feature on Police iPhones or Winscribe to record brief details regarding the arrest/incident; this to satisfy the Officers Evidential Statement where a prosecution file is to be generated
- OC's are to take full length iPhone photographs of the Detainee front/rear for later reference/comparison with evidential video footage
- Photos MUST include Individual MAP reference number and faces of detainee with the arresting officer
- OC/Escort are to control and /manage detainee throughout MAP triage/initial assessment
- Photographs MUST be emailed to ACD DCU SGT s9(2)(a)
- OC to provide necessary details to the receiving/processing member including MAP/MAK Documentation numbers, OC Name, QID, Station, Detainee; Name, DOB, Add, PRN, Reason for Arrest, Charge or PCW/recommendation.
- OC to accurately outline the circumstances of the offence committed to receiving member
- If possible, MAP documentation should be provided to arresting officers waiting with detainees in queues to speed up process

### **MAP Receiving**

- MAP Sergeant will issue PPE to the OC's to give to the detainee
- The MAP Sergeant will carry out assessments regarding incoming detainees, health & wellbeing, injuries, demeanour, mental state, and social distancing requirements. They will inform OC's and Escorts whether Escorts can return to the line or where they must remain to safely manage the detainee
- MAP Sergeants may accelerate the MAP regarding an individual detainee due to observations made or behaviours exhibited in the triage area
- OC's are to verify identification and record Detainee details
- Detainee is to have colour coded wrist band applied, complete with MAP Reference Number
- Receiving member is responsible for accurately recording offence/offender detail on arrest documentation
- Metal cuffs to be swapped for plastic-cuffs. It is recommended detainees always remain handcuffed to prevent opportunity for escape, however TENR must be applied to each detainee individually
- Processing staff will provide the Detainee with the 'Notice to Person in Custody' document and explain the NZ Bill of Rights as per usual practice
- Where a Detainee seeks legal advice, this should be facilitated as soon as practicable. (Bearing in mind the limitations available regarding privacy/legally privileged conversations)
- Current legal aid rosters are available at <http://pdla.lsa.govt.nz/Default.aspx>
- All general property to be placed directly into the large clear plastic exhibit bag, bag sealed in presence of detainee. Seals signed by Processing member and Detainee. Photograph of sealed bag taken where possible
- Detainees presenting with injuries/illness will be assessed and diverted where necessary for examination. They will complete a medical assessment and will advise where necessary on further medical intervention required. Possible uplift/transport to Hospital
- MAP Sergeant will advise on release/return of OC to front line. Where a prosecution file is warranted/required MAP Sergeant will reinforce with the OC that they are responsible for completing prosecution file for an attendee. Protest organiser files will be prepared by CIB

## **MAP Transports**

- Detainees may be loaded into custody vehicles from forward processing area for the purpose of transporting to the ACU
- Detainees may also be transported to their home address by police cars after receiving a summons from a staging area
- Segregation of COVID-19 Delta infected, 1M, 1K, Male/Female/Juvenile and Violent persons is to be maintained/managed by MAP Sergeants and vehicle crews
- Detainee MAK documentation, property and exhibits MUST accompany the Detainee from the MAP staging area to the custody unit
- This process will repeat until all Detainees have been triaged, received, processed, and transported to the DCU or released to isolate at their home address
- Transport crews are to advise Operation Commander and DCU of the number of Detainees on board and proposed transport routes
- If delivered to a residential address the route and address
- MAP Transport crew MSL: 2 AO/Const
- MAP Transport Crew to decant vehicle within confines of DCU Sally-port only and as per standardised prisoner receiving at DCU. Vehicles are not to be decanted outside of the DCU Sally-port
- Upon arrival at DCU, Transport crew to advise Op HQ via Radio
- Transport Crew are to be released from DCU upon Detainee searches being completed and all handed overs are complete. They are to return to MAP staging area or be otherwise directed by the Operation Commander

## **Auckland Custody Unit Receiving/Processing/Housing**

- DCU AO's are to meet and assist MAP Transport Crews with decant of vehicle and reallocation to DCU receiving Area
- If processing in the enclosed carpark area, provide a trolley and laptop to assist with processing
- Transport Crews are to provide DCU staff with all associated MAP/MAK documentation and Detainee property
- Transport Crew and DCU AO's will coordinate joint safe search of all incoming Detainees. To include thorough pat down search, walk through metal detector, wand metal detector
- Where time critical DCU AO's may need to manage incoming detainees utilising own resources to enable swift redeployment of transport crews
- Detainees shall be received in the usual fashion and loaded into the ECM
- ECM records to accurately indicate MAP Reference Number and any issues identified raised by Transport Crew
- DCU Sergeants are to carry out further assessments as necessary and in accordance with standard DCU practices
- DCU Sergeants will coordinate Detainee placement across the ACD DCU in accordance with Covid-19 operating procedures
- A separate Op Stop Delta Portfolio (Physical record of MAP/MAK documentation) should be maintained by DCU.
- Should the DCU capacity reach 27 then an alert is to go out to the other District Custody Units. Coordination should be undertaken by the AAA Manager
- Release and Bailing of Detainees is to be strictly managed, to mitigate the risk of the Detainee returning to participate in further activity that could result in subsequent arrests/charges
- The decision to release a prisoner will be made by the DCU Manager/Sergeant and will consider factors including propensity to commit further offences, opposition to bail, proposed bail conditions and COVID testing requirements
- Detainee property which is non-evidential and is being returned must be accounted for accurately
- Phones of protest organisers are normally seized for evidential purposes

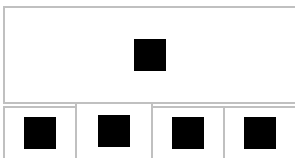

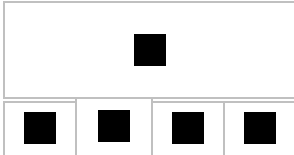

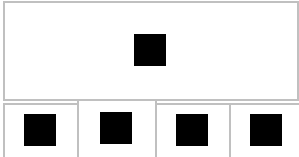

## Background

1. The Freedom and Rights Coalition (TFRC) have posted on their website about a “Mandates gone by 1st March’ event scheduled for Saturday 26 February 2022.<sup>1</sup> They have stated “we will march out these mandates at significant landmarks nationwide”. TFRC have posted that Auckland’s march will feature the Auckland Harbour Bridge (CWA) and that “these events are not to detract from what is happening on Parliament grounds but make peaceful protests more accessible to the masses of supporters”. The group have said that if the mandates aren’t lifted by Tuesday 1 March 2022 there are “mass rolling non-compliance actions underway that we will peacefully activate nation-wide, which will impact most New Zealanders”.<sup>2</sup>

## Methodology

2. This report has utilised information from open-source scanning and s6(c) [REDACTED]. The OSINT team was contacted and s6(c) [REDACTED].

## Protest tactics

3. At previous protests TFRC has held speeches. They have also marched on roads, blocking traffic in the process.<sup>3</sup> They commonly utilise bike convoys.
4. In November 2021, TFRC threatened to create a “massive gridlock” which was planned to consist of a motorcade moving at approximately 25kmph.<sup>4</sup> It is *possible* that this tactic may feature in the “mass rolling non compliance actions” they have threatened.

5. TFRC has sophisticated media capabilities. They typically livestream their protests to Facebook with real time commentary from hosts off site.<sup>5</sup> They have previously uploaded footage to Facebook of interactions with Police.<sup>6</sup>

## Locations

6. TFRC has indicated simultaneous marches are scheduled for Auckland, Tauranga, Napier, Wellington, Nelson and Christchurch.<sup>7</sup> They have stated that “details will be coming soon for each location” as they finalise these.
7. Previous Auckland based TFRC events have been held in the Auckland Domain.

## Numbers

8. The number of attendees at previous TFRC events has been reported at approximately 2000 by the NZ Herald.<sup>8</sup>
9. The Facebook page announcing the Mandates -7 Day- Countdown which the Saturday event is part of, received 1300 likes and heart reacts.<sup>9</sup> It is *almost certain* that some of those reacting positively towards the post are already at the Wellington anti mandates protest so will not attend. Commentary on the post is mixed, with some anti COVID19 mitigation programmes activists claiming that TFRC is being divisive as they have referred to some activists in Wellington as an “extreme fringe element”.

## Notable Individuals affiliated with TFRC

10. **Brian TAMAKI**<sup>10</sup> of Opaheke (CMS) and **Hannah TAMAKI**<sup>11</sup> of Opaheke (CMS) are co-leaders of Destiny Church. Following the organisation of a 2 October TFRC event, TAMAKI was charged with failing to comply with the COVID-19 Public Health Response Act 2020 and COVID-19 Public Health Response Order 2021. 13. **Jennifer MARSHALL**<sup>14</sup> of Flat Bush (CME) s9(2)(a)

The march will end at Victoria Park with a program and guest speakers yet to be identified. TFRC have encouraged one family from each family/group to travel back to Onepoto using public transport or carpooling to retrieve their vehicles, but it is unclear how many will comply. Participants intend to cross the bridge via the two lanes of the bridge on the far left-hand side. The group has their own security who will undertake traffic management. Organisers have indicated that participants will not be walking back across the bridge.

The buses will also run directly after the event to transport any supporters back to Onepoto Domain.

16. Supporters gathered at Onepoto Domain have been increasing since 0830hrs. Initially comprising of what appeared to be organisers consisting of marshals and security in hi-visibility jackets. Participants are displaying anti-government sentiments by displaying a upside down New Zealand flag on a pole and holding several Trump 2024 flags.

18. **Comment:** TFRC event post has received 524 reactions, 62 comments and 58 shares. Comments on the page are largely in support of the event with some commenting they wish to start their own 'freedom village' and indicating the Auckland Domain (CAA) as a possible location s9(2)(g)(i)
