## Partial transfer of your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) to the Ministry of Health (the Ministry) on 9 March 2022 for:

"Copies of the scientific research and evidence documents (including published papers) used by the government to justify their decisions on vaccine mandating workplaces.

All meeting minutes where vaccine workplace mandates were on the agenda, discussed and agreed. These are from any relevant government department."

On 24 March 2022, the Ministry asked you to clarify part 2 of your request. You responded with the following:

"Re point two - All meeting minutes where vaccine workplace mandates were on the agenda, discussed and agreed. These are from any relevant government department.

To clarify: I want to see the minutes from the Ministry of Health and the Covid 19 Ministers response team where decisions were made to go ahead with workplace mandates."

The Ministry believes that part 2 of your clarified request is more closely connected with the functions of the Department of the Prime Minister and Cabinet (DPMC). For this reason, I have decided to partially transfer this part of your request to DPMC under section 14(b)(ii) of the Act. You can expect a response from their agency in due course.

The Ministry will respond to part 1 as soon as reasonably practicable.
