Officer Notes:

Vehicle registration [REDACTED] was fleeing from police when it has turned right into Richmond Street from Ulster Street. Two of the vehicles tyres had deflated as the result of being spiked. Pursuing police vehicle KDP685 was in behind when [REDACTED] came to a stop approximately 50 m from the intersection with ulster Street. Police vehicle registration JRT392 has then crossed the centreline and positioned itself on an angle in front of the fleeing vehicle. [REDACTED] has responded by reversing into KDP685, damaging the indicator light on the vehicle. [REDACTED] has then driven forward into JRT392 and then into LWM28 causing moderate damage to both vehicles.
