Please find below an update on the situation in Israel/Palestine, and a suggested text for a tweet.

Update - 20/04:

- Late in the evening of 18 April, a rocket was fired from the Gaza Strip into Israeli territory. The rocket was intercepted by the Iron Dome air defence system, and crashed into the sea off Tel Aviv. No faction has as yet claimed responsibility for the rocket strike. This is the first such attack since 1 January.
- Hours later, the Israeli air force said it had hit a Hamas weapons manufacturing site in retaliation. Hamas claims to have used its "anti-aircraft defence" to counter the air raids, which caused no casualties, according to witnesses and security sources in Gaza.
- The UN Security Council convened an emergency closed-door session on 19 April to discuss the recent unrest, and hear from the Special Coordinator for the Middle East Peace Process, Tor Wennesland, following a request by France, China, Ireland, Norway, and the United Arab Emirates.
