





As we discussed, here is the Police National HQ directive on your clubs certification (Dated 23/8/13) .Keep me updated on how your discussions with the Army progress.

Just talking to Steve Lamb, NZDF re approval of HPC ranges. He has serious misgivings re the interaction of NZDF requirements and the HPC Range Standing Orders. Most of these are about rifles and shotguns, which I pointed out to him are not part of our approval, however, he pointed out that the use of steel targets has NZDF requirements which are not in the HPC RSO's. That being so we cannot condone the use of steel targets until the matter is resolved between HPC and NZDF.

Could you please inform the club that they cannot use steel targets until they have sign off from NZDF, and we have had the opportunity to review our decision in the light of the NZDF objections. I am now clear that the NZDF RSO's should take precedence over the club RSO's and the club RSO's need to reflect this. Could you please inform the club that they need to resubmit their request for certification once they have amended their documentation to reflect the NZDF requirements. Their documentation needs to include the NZDF RSO's and any other agreements/documentation of relevance to the relationship between the club and the range owner (NZDF).

The club should resubmit their documentation to us by 30 October 2013. After this date we will withdraw our approval if we are not satisfied that it is accurate.

## Good Evening All

The Committee meet tonight to clarify an issue with the use of steel targets on the range. Effective immediately the following is to apply.

When using steel targets on the range you need to ensure that you comply with the Trentham Range Standing Orders 20 Jun 2011: Section 359 Steel Targets

The relevant sections that are provided for are:

## Sub Section A item 2:

Steel targets may only be used if they are provided with a picochet suppression shelter as described section D which states: Target Centres are to be positioned so that they relevant CoF, when applied to the shooters position is completely captured by the stop butt or bullet catcher impact slope. Steel Targets positioned inside a bullet catcher do not require individual target ricochet suppression shelters as the bullet catch is designed to capture post impact hazards(Less backsplash)

Sub Section B item 3

Stop Butt: To be positioned within 1.5m of the stop butt toe. Each Target is to be provided with a ricochet suppression shelter

Sub Section B item 4

Bullet Catcher: A minimum of 500mm inside a line perpendicular to the forward (closest to the shooter) edge of the canopy. So long as the bullet catcher is designed to capture all post-impact hazards (less backsplash) individual target ricochet suppression skelters are not required.

Thank you for providing the attached documentation.

It is acknowledged that NZ Police require range standing orders from a civilian shooting club to obtain approval for the use of pistols. However, consultation with NZ Police and

of Police National Headquarters revealed that Trentham Camp Collins Range Orders were not submitted with the initial HPC request for pistol use certification. Perusal of the HPC Range Standing Orders (RSO) reveal that in some respects, directly relating to range safety, they are in conflict with Trentham Camp Collins Range Orders. Mr Satlands acknowledged that the HPC RSO require amending to avoid confusion that could arise and lead to safety issues. Details as follows:

A. NZ Police Range Certification Approving Pistol Use - 05 Aug 13 (attached)

B. AGS (F/No: 7795/7/1) Development of the Heretaunga Ristor Club Range at Trentham dated 09 Nov 04 (not attached).

C. Trentham Camp Collins Range Standing Orders - 20 Jun 11 (attached (please note the cover was missed during the scanning))

D. HPC produced Range Standing Orders - Final 2013 (attached)

## NZ Police Approving Pistol Use

Ref A, provides approval for the HPC to use pistols up to 12.5mm (.50 cal) in all 5 firing bays of the range complex. The surrent Collins Range/HPC Range Safety Cert will be amended to reflect this approval as soon as practicable. Until the safety certificate has been amended the use of pistols by the HPC remains approved in Bays 1 and 3 only.

## HPC Range Standing Orders

Ref D. Safety Rules - para 09. This para is not required in HPC RSO; and is also in error. Therefore, it needs to be removed. As acknowledged by Mr Gatlands, the Royal NZ Police College (RNZPC) have requested use of the range under conditions of the Memorandum of Understanding between NZ Police and NZ Defence Force, and therefore a separate RSO is required for RNZPC use of Bay 5 of the range. This is currently being drafted by both this office and RNZPC. A copy can be forwarded to the HPC when it has been completed, if required.

Ref D - Priority of Use para 6. This para seems to have omitted the conditions set out IAW the HPC License dated 01) Jul 96, "Use of the Heretaunga Pistol Club Range", para's 4 - 7, which allows NZDF and other organisations providing this permission is not extended to other civilian shooting clubs. This too was agreed to by Mr Gatlands.

Ref D - Moving Targets - para 11. As discussed and agreed by Mr Gatlands, this para is misleading and could lead to safety issues. Para 11 needs to be rewritten to exactly replicate what is stated in Ref C, "Target Limitations", para 359, sub-para h.

Ref D - Steel Plates - para 13. This para is inaccurate and omits the specific details for safe use of steel plate targets on the range. That omission may create safety hazards to HPC members when

engaging these targets. This point was also agreed to by | . Para 13 is to be rewritten to exactly replicate what is stated in Ref C, "Target Limitations", para 359, sub-para, a, (2) and sub-para b (3).

Yes, the attached Use of Steel Targets meets the requirements as stated in Ref A, thank you.

As discussed during our phone conversation last Fri night, Ref B requires amending to reflect Ref A, details as follows:

Ref B requires recognition that Ref B is used in conjunction with Ref A and where any discrepancies exists between them, the most restrictive of the two orders takes precedents.

Ref B requires recognition of the License Agreement held between the HRC and NZDF, which then affects Ref B, para 6 - Priority of Use, which needs to be reworded in accordance with the statement in the License Agreement. Also recognition of the Army General Staff document (F/No: 7795/7/1 - 09 Nov 04) Development of the Heretaunga Pistol Club Range at Trentham needs to be included in Ref B.

Ref B, para 11 - Moving Targets - requires rewording due to confusion that may be created this para as that moving (could mean traversing) targets can be engaged at any distance but if closer than 25m the arcs of fire need to be marked with brightly coloured posts. This is incorrect and requires amending to reflect the agreed and accurate nature for engagement of Aerial Clay Targets as stated in Ref A para 359 - Target Limitations, sub-para, h - Moving Targets. This is the only form of moving targets permitted for engagement, all other target engagement on the range complex is from a static fixing position to a static target.

Ref B, para 9 - Safety Rules - sub-para f - Police. This para is required to be removed as this may lead to confusion. As previously explained, the Police are using the range under the requirements of a government Minute of Understanding held between NZ Police and NZDF. This again reflects the nature of the License Agreement. A separate Range Standing Order is being developed for NZ Police use of Bay 5 only of the range complex. Plus, the stated cone of fire and engagements distances are incorrect, again could lead to confusion.

Also, a copy of Ref A needs to accompany Ref B for submission to NZ Police so both copies held by them for reference purposes

Good afternoon Gentlemen,

Thank you for providing the attached documentation.

It is acknowledged that NZ Police require range standing orders from a civilian shooting club to obtain approval for the use of pistols. However, consultation with NZ Police and it of Police National Headquarters revealed that Frentham Camp Collins Range Orders were not submitted with the initial HPC request for pistol use certification. Perusal of the HPC Range Standing Orders (RSO) reveal that in some respects, directly relating to range safety, they are in conflict with Trentham Camp Collins Range Orders. acknowledged that the HPC RSO require amending to avoid confusion that could arise and lead to safety issues. Details as follows:

### References:

A. NZ Police Range Certification Approving Pistol Use - 05 Aug 13 (attached)

B. AGS (F/No: 7795/7/1) Development of the Heretaunga Pistol Club Range at Trentham dated 09 Nov 04 (not attached).

C. Trentham Camp Collins Range Standing Orders - 20 Jun 11 (attached (please note the cover was missed during the scanning))

D. HPC produced Range Standing Orders - Final - 2013 (attached)

## NZ Police Approving Pistol Use

Ref A, provides approval for the HRC to use pistols up to 12.5mm (.50 cal) in all 5 firing bays of the range complex. The surrent Collins Range/HPC Range Safety Cert will be amended to reflect this approval as soon as practicable. Until the safety certificate has been amended the use of pistols by the HRC remains approved in Bays 1 and 3 only.

## **HPC Range Standing Orders**

Ref D - Safety Rules - para 09. This para is not required in HPC RSO; and is also in error. Therefore, it needs to be removed. As acknowledged by Mr Gatlands, the Royal NZ Police College (RNZRC) have requested use of the range under conditions of the Memorandum of Understanding between NZ Police and NZ Defence Force, and therefore a separate RSO is required for RNZPC use of Bay 5 of the range. This is currently being drafted by both this office and RNZPC: A copy can be forwarded to the HPC when it has been completed, if required.

Ref D Provity of Use - para 6. This para seems to have omitted the conditions set out IAW the HPC License dated 01 Jul 96, "Use of the Heretaunga Pistol Club Range", para's 4 7, which allows NZDF and other organisations providing this permission is not extended to other civilian shooting clubs. This too was agreed to by Mr Gatlands.

Rev D - Moving Targets para 11. As discussed and agreed by Mr Gatlands, this para is misleading and could lead to safety issues. Para 11 needs to be rewritten to exactly replicate what is stated in Ref C, "Target Limitations", para 359, sub-para h.

Ref D - Steel Plates para 13. This para is inaccurate and omits the specific details for safe use of steel plate targets on the range. That omission may create safety hazards to HPC members when engaging these targets. This point was also agreed to by Mr Gatlands. Para 13 is to be rewritten to exactly replicate what is stated in Ref C, "Target Limitations", para 359, sub-para, a, (2) and sub-para b (3).



Through conducting Monday checks of all Trentham Camp Ranges after each weekend period of use, have noted the following as observed on Collins/HPC Range.

- The southern tilt-a-door of the target shed located in Bay 1 was open and in its fully raised position. I've lowered and closed the door, which appears to be secured. After checking the Camp Guard Hut Key Register, the last entry for returning Collins Range key was yourself on Sat 7th Sep 13 at 4:20 pm. No entry was made by any HPC member for the range key on Sun 8th Sep 13.
- Bay 1 5 x .22 brass was found semi-centrally in the bay by the firing point line.
- Bay 2 5 x .22 brass found along the firing point line,
- Bay 3 5 x .22 brass found in lane 5 by the fixing point line.
- Bay 3 3 x projectile strike on the new protective timber installed in front of the target turning mechanism in lane 3, although, penetration does not appear to have occurred, however, it is outside the established sone of fire for this bay. This was observed at the last range inspection with Lachlan and noted in HQ WRSC Range Safety Certificate letter dated 07 Aug 13.
- Bay 5 7 x .22 brass found at the 100m firing mound on the southern side of the mound,
- Bay 5 10 x .22 brass found approximately at the 25m mark on the southern half of the bay floor.
- Bay 5 Stones approximately 30mm in diameter are appearing on the range floor (either from the natural rising phenomenon or from water erosion) centrally and on the northern side of the bay floor.

It is respectfully asked that all memebers please be educated in:

- Clearing each firing bay of brass (brass bins are provided in each bay for this) at the completion of each firing activity,
- . Maintaining the appropriate cone of fire for the particular firing bay/discipline, and



I'll go over to the range today to confirm the all is ok and advise accordingly.

Just a note for continued safe use of the range. Part of a Range Officer's responsibility is to inspect range bullet catchers prior to firing into them. If a bullet catcher is found to be in a condition like that of the Bay 3 or has exposed foreign materials (rock, large stones, steel etc.), or contains rabbit holes, the foreign materials are to be removed and all cavities filled in. The bullet catching face angle is then to be restored to the required safety specification (30 degrees minimum, 34 degrees optimum) before being used. It is respectfully asked that this safety requirement information, as a reminder, be passed on to all HPC Range Officers please.



Yes that timing suits me, so let's lock it in.

In regards to the other discussion point: (if I have misunderstood anything please let me know for clarity, as I was not involved in the initial process but have been tasked with getting this tidied up)

As you are aware HPC were asked by yourself to got Police certification and RSO's (that comply with that certification) as Army certification were no longer acceptable to Police which I believe was in 2012. We had some of our bay's closed in April 2013 until such time as we obtain the Police Certification.

We obtained the Police Certification on the 21st of Aug which we supplied a copy to yourself and the CO (by Lachlan). On the 23rd of August we received via Police the attached email. It was our understanding that Police had rescinded our certification based on their conversations with yourself - as it turns out this was not quite correct. We were disappointed that this was not discussed with us in the first place prior to contact with the Police.

We were then advised that you would open the range subject to certain conditions until this matter was sorted out (as per our previous correspondence)

You had advised PNZ on the 27th of Aug that this matter was in dispute. PNZ sent this on to the Certified Range Inspector who advised that this matter was been looked at. HPC then stayed out of the issue and allowed the Certified Range Inspector to follow up. As you had initiated this contact to PNZ, Police etc HPC was under the impression that you were involved in the process.

As Police had set a deadline of 31 October HPC were concerned as to what was happening. The Certified Range Inspector advised that 5 days after his contact Police had accepted a slightly amended version of the RSO's in accordance with their responsibilities of the act, and that HPC

should wait to receive the new RSO and certifications etc. Again at this time it was our belief that you were involved and had been notified directly as we were not in the loop.

On the 1st of November I contacted to find out what the issue was and he advised me at that time that I should see the amended documents by the 8th of Nov. Both the President and I tried to follow up with after this date but had been unsuccessful in getting hold of him

I was able to get hold of on the 20th of November and he advised that he still did not have the time to get this to us as he had been extremely busy. I asked when we were likely to see this as we were concerned that we did not have Police Certification. He stated that he would try to get it to me by Friday (22nd of Nov) but he was going away and may not get it done by then. He also advised that Police had not rescinded the nitial certification and RSO's and that we should be using these until such time as the new documents are sent to us. he reiterated that the current certification was still in place. I advised the ERSO of this which is why he placed the documents in the box yesterday when he became aware.

Again I believed you were in the loop on all of this as we had not been. Once we had the amended copies it was our intent to arrange a meet with yourself and the CO to go over the documents and ensure that everything was in place for us to follow these. We did not want to initiate contact on this matter until we had obtain the corrected documentation as it would be irrelevant to discuss with the wrong documents, that is why have not been able to do anything as we still have not received anything back at this time.

At this time I still have not received any amended versions and once I do you will be notified immediately. I am attempting to contact Paul today (even though I know he is away) as we would like to get this matter tidled up as quickly as possible. Inope that clarifies the matter but if you have any further questions etc please feel free to let me know.

I look forward to catching up on Tuesday, were would you like me to meet you?

Good Morning

Receipt of your email of 4 December is acknowledged.

You did not specify what provision or provisions of the HPC License you were referring to, but contrary to your contention that the provisions of the Glub's licence have been forgotten I can assure you that it has very much been borne in mind As you are no doubt aware, paragraph 4.2 of the current license (dated 01 Jul 96) provides that the Club shall at all times obtain the Crown's permission prior to entering the range. Providing dates and times of intended use is an essential and integral part of obtaining permission. Your attention is also drawn to paragraphs 4.2 f. and 4.2 g. of the Lisence.

Prior to my commencing employment with NZDF, the HPC daily operating hours on Collins Range were 8.60am to 5.00pm. Following a meeting attended by you, I (then Officer Commanding), and me, the HPC's request to change the daily operating times to 7:00am to 6:00pm was approved. Those times are what are currently approved; except where an individual booking request has been received for extended times. In most cases such individual requests have been approved.

There has been no change to the long-established procedure requiring HPC, in common with the other licensed clubs that use Trentham Camp Ranges, to provide daily operating times for the use of their licensed Ranges.

It is of real concern that you advise that on numerous occasions you have expelled persons from the danger area of Collins Range. Apart from observing that HPC and its members have no right to do so, and therefore expose themselves to legal consequences for taking the law into their own hands, it is particularly concerning that such incidents have not been reported to Range Control WRSC to enable some proper and effective steps to be taken to deal with such intrusions.

The purpose of requiring timings from range users is simply safety. Range Control WRSC is responsible for the daily running of all the out-door ranges at Trentham Camp. The current system is quite simple, very effective, and requires minimal input by the intended range user. However, no

control system can work effectively if start and finish times are not provided by the intended user as to when a club or unit is to conduct live firing on a particular range. This is extremely important as the Trentham Range Area has multiple cross-over range danger areas.

Units conduct non-live firing training and contractors work within range danger areas. It is imperative that these units/contractors can undertake their particular tasks in a safe environment. This cannot be achieved without knowing within what timings a range that affects the danger area is going to be used. This point is well illustrated by the fact, to which you appear to take exception, that pest control has been carried out in danger areas without the need to advise every member of using clubs, because Range Control WRSC is in a position to know when those danger areas are not going to be at risk due to clubs advising as to start and finish times for live firing.

It is to be applauded that you deplore intrusion into the danger areas "over confusion over times". As Range Control WRSC co-ordinates all activities on all ranges, you will consequently appreciate that it is essential for Range Control to be advised as to accurate timings for the conduct of live firing on all ranges, including the HPC on Collins Range to avoid the risk of inadvertent intrusion.

Your assertion that HPC has strict safety standards is not one which the record would support. There are a number of potentially risky situations which have occurred which sould have been avoided by adherence to established safety procedures on the part of HPC members, especially on the part of Range Officers who are responsible for activities on the range.

My email as to the timings for the Christmas close-down was sent in the absence of any request for any other timings on any particular days. If the HPC seeks any extended hours for extending live firing times on any particular days then will be more than willing to entertain, and respond to, any such a request; co-ordinating it with all other range activities. At this point no request for approval of access, in terms of the HPC licence, has been made.

I thank you for the booking over Christmas, unfortunately the provisions of our licence seem to have been forgotten, must reiterate, there is no and never has been a time frame provided for under our licence and none has ever been accepted by the club, unfortunately we have had to on several occasions make this point clear. During the normal use of the range we have been able to successfully control the access to our danger area and have on numerous occasions, expelled people from that area due to their lack of knowledge regarding our licence or indeed when they were in breach of your booking system

As a gentleman who proclaimed to be your head of security told a member of HPC he has a permit to hunt in our danger area and can go into our danger area at any time we are as a result of any time frame extremely concerned for the safety of our members, the public and your staff. We can not have our members being put in a position of injuring any person who had gone into our danger area in contravention of our licence regardless of whatever authorisation they may think they have.

We are required under our licence to indemnify defence against injury, we can only do this with the

range under our complete control and in accordance with the provisions of our licence; in order to maintain our strict safety standards and resultant safety record we can not and will not tolerate any chance of an incursion into our danger area due to confusion over times of use particularly when our members are well aware our licence has no provision for defence to add their own conditions.

I do realise you believe there is a need for a finish time in case you need to send a person to check if all is ok in the event the key is not returned, but this can be easily be achieved. We have tolerated the times frames supplied previously but this is due to them closely reflecting the hours of light. Due to the fact we do not shoot after dark we require any finish time to be around or after dusk, we are as Steve Lamb pointed out at the meeting with property group attended by Myself, and permitted to shoot during twilight hours. This is something that has

been done quite often in the past during the summer months. There is a requirement for shooting into the evening at this time of year as people get ready for the New Year competition season, as such our members may be on the range well into the evening.

We require you to amend your notification of the booking for HRC over the Christmas period to more closely reflect the provisions of our licence and to accurately reflect the use the range will get over the Christmas period. In the interest of a temporary solution to the issue we suggest the following until a long term solution more acceptable to HPC is found.

21st - 24th, 26th - 31st **7:00am - 9:00pm** Dec 13 and 1st - 5th **7:00am - 9:00pm** Jan 14. Please note that normal range bookings will resume to weekends, public holidays (less Good Friday) and individual booking requests from the 6th Jan 14; this will allow our members to work their shooting around work and family commitments over this busy period.



### Good afternoon

Have received the amended copy of the current HPC Range Standing Orders (RSO) - 2013 from of Lower Hutt Police.

Unfortunately, the amended paragraphs 11 - Moving Targets and 13 - Steel Plate Targets do not reflect the appropriate safety conditions for safe use of these targets as described in:

- · HPC Range Submission 26 Aug 01,
- Army General Staff document Development of the HPC Range at Trentham 99 Nov 04,
- Heretaunga Pistol Club Range Standing Orders version 2 01 Jun 09
- Trentham Camp Collins Range Standing Orders 20 Jun 11

## Paragraph 11 - Moving Targets

The title of this paragraph is misleadingly worded. It should be titled "Aerial Clay Targets" or "Aerial Sporting Clay Targets" - as you know the engagement of moving ground targets on Collins/HPC Range is not

#### approved.

Trentham Camp Collins RSO 20 Jun 11 also uses this title in its paragraph, which needs to be amended to one of the descriptions above.

Current HPC RSO - 2013 provides a very vague description of where and how HPC members are to set-up and engage aerial clay targets on the range. The wording used on the above bullet pointed documents

provide clear instruction, descriptions for use and the maximum shot size permitted. This information is required to be entering into current HPC RSO - 2013. Moreover, I have observed that the orange plastic

conduit shooting squares or boxes that were located in each north-eastern corner of Bay's 4 and 5 and the coloured markers indicating the arcs of fire for these target types are no longer located on the Bay's. Those

are necessary if aerial clay targets are to be safely engaged. In conversation with Mr J. Smith (HPC RO and Committee member) it was revealed that the HPC do not engage aerial clay targets anymore. Is this

correct?

### Paragraph 13 - Steel Plate Targets

Your email dated 26 Aug 13 provided an attachment advising all HPC members to comply with the Trentham Camp Collins RSO - 20 Jun 11 and that attachment provided the requirements for safe use of steel targets on Collins/HPC Range. However, through conversations with various HPC Range Officers (RO's) with one of these RO's being a HPC Committee Member revealed confusion over the positioning and engagement of these targets. It is both interesting and seriously concerning that the HPC Committee Member claimed that the club does not have to use ricochet protection shelters when these targets are set-up on a range floor.

### **Current Status**

This office has serious safety concerns for HPC members and other users of the area over the HPC engaging steel and aerial clay targets as currently described on HPC RSO - 2013. Therefore, the use of steel and

aerial clay targets on Collins/HPC Range is **not approved** until current HPC RSO -2013 have been amended to the reflect the safety requirements as described in the attachment of your email dated 26 Aug 13 and

in the above bullet pointed documents.

I believe a meeting needs to be held as early as possible (possibly mid Jan 14) to address the above and seek clarity in understanding the HPC License.

Please distribute the above (non-approved use of Steel Plate and Aerial Clay Shotgun Targets) to the club membership.

A hard copy of the new Range Safety Certificate dated 19 Dec 13 has been placed on the range sign and another copy within the Camp guard but for your retention. It's in an envelope with your details for your uplift at your convenience.
