Official Information Act Request

I write further to my letter of 12 July 2022. You have asked for information about outsourced procedures.

I would like to request the following information for each of the DHBs in New Zealand, split by DHB.

- 1. The total number of procedures outsourced by year (including the year to date) for the past five years.
- 2. For each year, provide a breakdown of the type of procedure.

Please see information in the following table which summarises the procedures outsourced by specialty over the five calendar years and the YTD (to 31 May 2022). This includes those procedures completed on a fully private basis and those with a mix of Northland DHB and private theatre staff performed in a non-NDHB site. There are over 400 individual procedure types outsourced over this period.

3. For each year, provide the total spend on outsourced elective surgeries.

The table below summarises the cost of the outsourced procedures as recorded above. Please note that this excludes fees paid to private Anaesthetists and/or surgeons. Our financial reporting system does not capture the difference between locums and private fees.

4. For each year, provide the amount that these surgeries would have cost the DHBs if they had not been outsourced.

Outsourcing is routinely conducted due to a lack of in house capacity. Accordingly completing these procedures in house was not possible. The cost difference between completing procedures in house versus outsourced varies depending on the contractual arrangements and procedure type.
