Thank you for your email of 1 August 2022 in which you request the following under the Official Information Act 1982 (OIA):

The minister replied "None to date, but I understand briefing is under preparation" (as at 23 September 2021). I would like to request a copy of the briefing referred to here.

This letter is to advise that the timeframe for responding to your request is being extended by 20 working days, to 26 September 2022. This is because consultations necessary to make a decision on your request are such that a proper response cannot reasonably be made within the original time frame (section 15A(1)(b) of the OIA refers).

I am also partially transferring documents 1,4,5,6,7,8 and 15 of your OIA to the Minister of Foreign Affairs because the documents are believed to be more closely connected with the functions of

the Minister of Foreign Affairs (section 14(b)(ii) of the OIA refers). In these circumstances, we are required by section 14 of the Official Information Act to transfer your request.

You will hear further from the Minister of Foreign Affairs concerning the transferred briefings.

However, if this process is completed before 26 September 2022, the response will be sent to you as soon as possible.
