Dear 9(2)(a),

Thank you for your recent correspondence.

As you may be aware, *The Last of Us* videogame was originally released in *June 2013* and remastered for PS4 in *July 2014*.

However, following our discussions earlier this year with both the FVLB and the OFLC, it was agreed that due to,

- the period of time that has elapsed since the classification of the original game, and
- the changes that have been made to the upcoming release of *The Last of Us Part 1 for PS5* (\*see also game description below available on the PlayStation Store)

that a full review and submission to the OFLC would be required prior to our release of the game to the public.

Consequently, *The Last of Us Part 1 for PS5* was submitted for classification by the OFLC and rated NZ R18 on *1<sup>st</sup> July 2022*.

Please note, although the game is currently available for pre-order on the PlayStation Store, it will not be made available for consumers to purchase and play until September 2<sup>nd</sup> 2022.

*\*The Last of Us Part 1 for PS5 whilst based on the past releases of The Last of US has been completely rebuilt from the ground up using Naughty Dog's latest PS5™ engine technology with advanced visual fidelity, fully integrated DualSense™ wireless controller features and more. The game has had a total overhaul of the original experience, faithfully reproduced but incorporating modernized gameplay mechanics, improved controls and expanded accessibility options. As stated on the game's website; feel immersed in improved environmental storytelling, effects, facial animations, and enhanced exploration and combat.*

We are confident in your review process, however, we do not have any further information or comment to provide in relation to the game, or to the submission made by a member of the NZ public.

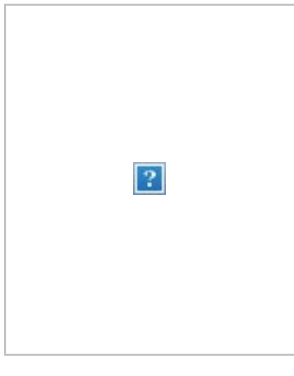

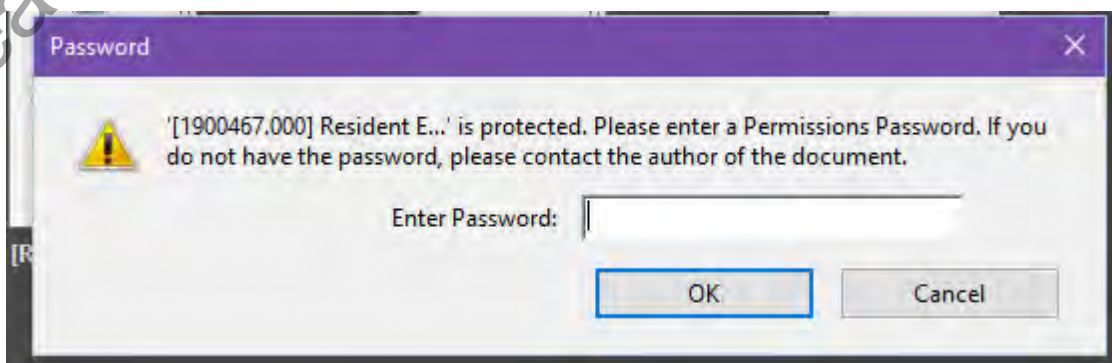
