- Contractors have installed three, solar-powered, wind anemometers together with air quality meters
- An initial environmental assessment has been completed to shape environmental strategy and planning. An initial avifauna desktop study has not revealed any red flags or unexpected results. Preliminary regional traffic movement modelling has also been largely completed and they will now be shared with waka Kotahi
- Next stages of the project will be focused on in-depth reviews of key social and environmental (birdlife and natural landscape) aspects as well as the economic and social impact analysis.

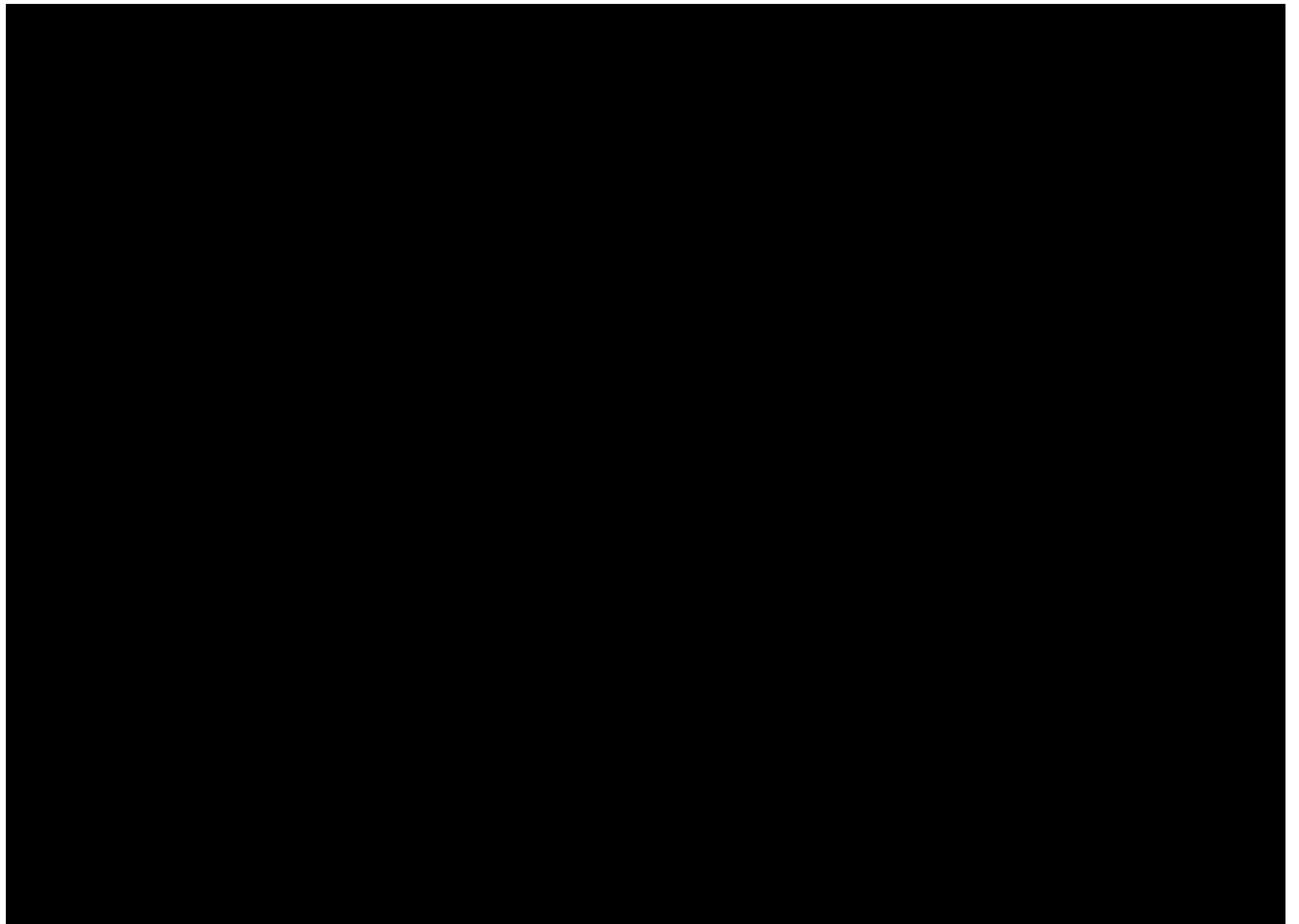
