Thank you for your email of 26 November 2023 to the Ministry of Business, Innovation and Employment (MBIE) requesting, under the Official Information Act 1982 (the Act), the following information:

...communications between MBIE and Belinda Storey and/or Climate Sigma

In responding to your request we searched for records where:

- the email is sent from the domain **mbie.govt.nz** to a climatesigma.com address
