

Memorandum of Understanding

1. PURPOSE

This Memorandum of Understanding sets out the terms of the collaboration to be developed by Radio New Zealand Limited of 155 The Terrace, Wellington 6011, New Zealand (**RNZ**) and Community Access Media Alliance Aotearoa New Zealand Incorporated of 14 Kotare Street, Fendalton, Christchurch, 8041 (**CAMA**) to the mutual benefit of each entity. This collaboration will not have any effect on the editorial and organisational independence of either partner.

2. SCOPE OF COLLABORATION

Sharing and promoting content

- RNZ will make RNZ news bulletins available to CAMA member stations for re-broadcasting (subject to RNZ resolving any issues relating to third party content rights).
- RNZ will make select programmes and podcasts available to CAMA member stations for re-broadcasting.
- CAMA member stations will make their content available to RNZ for re-broadcasting (subject to CAMA resolving any issues relating to CAMA member station operational capacity, third party content rights, and content-maker permissions with such permissions not to be unreasonably withheld).
- CAMA member stations that take up the opportunity to re-broadcast RNZ content will regularly promote RNZ content on terms to be negotiated and agreed between RNZ and the member station, in proportion to the content being picked up.

Sharing office and studio facilities

- CAMA member stations will make office space and studio facilities available on a casual basis to RNZ staff visiting their regions, as long as it does not conflict with the member stations' own activities.

3. UNDERSTANDINGS, AGREEMENTS, SUPPORT AND RESOURCES

One-off content-sharing will be negotiated and agreed by email case by case between RNZ and the relevant member station. Any more extensive or ongoing content-sharing will be covered by a formal licence agreement between RNZ and the relevant member station, addressing the following areas:

Content, platforms and territories

- RNZ and the member station will devise by agreement which specific content is available to be shared and the platforms and territories where it is permitted to appear.


Attribution

- RNZ and the member station will devise by agreement a format for attribution of the content drawn from each other, suiting the varied formats and platforms where it will be accessed.

Reporting

- RNZ and the member station will devise by agreement a method of reporting on the use of each other's content and sharing audience information, including podcast downloads.

Day-to-day contact

- RNZ and the member station will nominate a key contact in each organisation to provide day-to-day liaison and be a conduit for easy communication.

4. PERIOD OF AGREEMENT

One year, from 4 November 2023 to 31 October 2024, renewable by mutual agreement.

5. MONETARY AND PERFORMANCE TERMS

This agreement assumes that any sharing or promoting of content, or sharing of office and studio facilities on a casual basis, will occur without financial charge.

6. DISPUTES

If any dispute or difference cannot be resolved between the parties by active, open and good faith discussion, the parties will enter into mediation. However, this Memorandum of Understanding may be terminated immediately by either party should this memorandum be seriously breached.

7. REVIEW

The parties will meet quarterly to review the operation of this Memorandum of Understanding.

8. AMENDMENT

This Memorandum of Understanding may be amended at any time by agreement in writing between the parties.




