I refer to your request of 14 December 2017, made under the Official Information Act 1982 (OIA), for copies of all briefings made to the Minister of Defence in relation to Operations Takapu and Troy, and specifying the following:

- *any briefings, emails, letters, or reports, etc, made to the Minister of Defence, or his office, before the decision was made to proceed with Operation Takapu;*
- *any briefings, emails, letters, or reports, etc, made to the Minister of Defence, or his office, before any decision was made to proceed with Operation Troy;*
- *any briefings, emails, letters, or reports, etc, made to the Minister of Defence, or his office, on the implementation of Operation Takapu; and including any reports, etc relating to the consideration of extending this operation beyond January 2018;*
- *any briefings, emails, letters, or reports, etc, made to the Minister of Defence, or his office, on the implementation of Operation Troy.*

The mission name Operation Takapu is assigned to the 2014 Middle East deployment of a P-3 Orion aircraft to the United States Naval Forces Central Command and the Combined Maritime Forces for maritime security surveillance. The mission name Operation Troy was originally assigned to the NZDF P-3 Orion Air Surveillance Task Unit prior to its deployment to the Middle East in 2003. On its return to New Zealand in 2004, the mission name was transferred to the NZDF Logistics Hub which remained in the Middle East to provide an essential logistics and transport hub for all NZDF operations in the Middle East and Africa.

Enclosure one is a 2015 brief to the then Minister of Defence and the then Minister of Foreign Affairs. Information relating to operational detail and other nations is withheld in accordance with section 6(a) of the OIA where making that information available would likely prejudice the security or defence of New Zealand or the international relations of the Government of New Zealand. Financial information relating to future budgets is withheld in accordance with section 9(2)(f)(iv) to maintain the confidentiality of advice tendered by Ministers of the Crown or officials. Other advice is withheld in accordance with section 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank expression of opinion by or between or to Ministers of the Crown. The public interest does not outweigh the good reasons to withhold the information in this instance. Information beyond the scope of your request has not been included.

Enclosure two is a list containing summaries of updates to the Minister of Defence on Operations Troy and Takapu from January 2017 to February 2018.

As these missions originated in 2003, no briefings, emails, letters or reports to the Minister of Defence, or his office, before the decision was made to proceed with these operations, could

be found. This part of your request is therefore declined in accordance with section 18(e) of the OIA as the information requested does not exist or could not be found.

No briefings, emails, letters, or reports on their implementation could be found. This part of your request is therefore declined in accordance with section 18(e) of the OIA as the information requested does not exist or could not be found.

**NEW ZEALAND DEFENCE FORCE CONTRIBUTIONS TO MARITIME SECURITY
OPERATIONS IN THE MIDDLE EAST REGION 2015 – 2020**

Purpose

1. To seek Cabinet approval for a series of New Zealand Defence Force maritime security deployments in the Middle East region between December 2015 and June 2018. Approval in principle is sought for further maritime security deployments from July 2018 to December 2020.

Executive Summary

2. Building on New Zealand's experience in supporting maritime security operations in the Middle East region, approval is sought for New Zealand Defence Force maritime security deployments between December 2015 and June 2018. These include:

- a. An Orion aircraft air surveillance detachment to the Middle East for a 6-12 month period in 2017;

3. Approval is sought to extend the New Zealand Defence Force logistics support hub **s. 6(a)** beyond the current mandate of April 2017, to June 2018, with approval in principle sought to December 2020. Approval in principle is sought for a range of further maritime security deployments from July 2018 to December 2020.

4. New Zealand has a strong strategic interest in the Middle East and Africa region given the disproportionate effect events in the region have on international security and the world economy. This strategic interest has driven New Zealand's past maritime security deployments to the region. The deployments proposed in this paper would also contribute to New Zealand's broader national security interests.

5. If these proposals are approved, New Zealand would be able to take a more deliberate and planned approach to contributions to maritime security operations in the Middle East. This would enable the New Zealand Defence Force to be more proactive in making offers to contribute personnel and assets and in seeking roles best suited to the New Zealand Defence Force in coalition operations.

6. Relevant ministers would be provided with further details ahead of each of the deployments between December 2015 and June 2018. For the deployments from July 2018 to December 2020, further advice would be provided and Cabinet approval sought in late 2017 or early 2018 for the various elements of the proposal.

Background

7. New Zealand has contributed to maritime security operations in the Middle East and Africa region since 1995 including in a number of international forces and commands. These include operations to: counter piracy, terrorism, and smuggling; enhance maritime safety and security; and conduct maritime surveillance. If agreed, the proposals outlined in this paper would enable New Zealand to maintain its current level of support to maritime security in the region.

8. Over the past five years the New Zealand Defence Force has deployed the following personnel and force elements to security operations in the region:

Contribution to international peace and security

9. The security environment in the Middle East and East African ocean regions is impacted by a number of different factors, including conventional maritime and air forces, piracy, transnational crime and terrorist activity. The region is of global strategic significance due to its importance as a trade and transit route for both legal and illicit cargo. A relatively modest contribution to maritime security can have a significant effect in the immediate region and beyond, in disrupting illegal activities and maintaining stability.

10. Transnational crime in the region centres on illicit trafficking by sea, with the smuggling of narcotics, charcoal, weapons and people being of greatest concern. While weapons tend to remain within the region, smuggled drugs and people are usually destined for Europe and some narcotics reach South East Asia and beyond. Such criminal activities fund terrorist organisations operating throughout the region and challenge the stability of fragile African states.

11. Operations such as those conducted by Combined Maritime Forces Task Force 150 play an important role in promoting maritime security through countering terrorist acts and related illegal activities. While deployed to the Combined Maritime Forces Task Force 150 in May and June 2015, the frigate Te Kaha was involved in intercepting a total of 257 kilograms of heroin, contributing to efforts to prevent drug trafficking and stem the flow of funds for terrorist activities in the Middle East region and internationally.

12. The three counter-piracy operations in the region¹ along with other measures have contributed to reducing pirate activity. Piracy has significantly decreased since mid-2011 and the area of operation for counter-piracy operations has shrunk. However, the threat from piracy is likely to remain a long-term issue, albeit at lower levels than in the past, until stable governance and economic development is restored in Somalia.

Direct New Zealand interest

13. New Zealand has a strong strategic interest in the Middle East and Africa region given the disproportionate effect events in the region have on international security and the world economy. This, along with making a contribution to international efforts to prevent piracy and transnational crime in the region, has driven past maritime security deployments in addition to our other commitments in the region.

14. The proposed deployments would contribute demonstrably to New Zealand's broader national security interests. These include:

- a. contributing to regional, and therefore global, security and stability;
- b. supporting efforts to safeguard freedom of commerce and navigation, enhancing security in an area of trade and economic importance to New Zealand, which is particularly important given the value of exports to New Zealand shipped through the Suez Canal;
- c. maintaining and enhancing our reputation as a contributor to international peace and security;
- d. enhancing New Zealand's bilateral and multilateral relationships, including our defence linkages;
- e. supporting interoperability with security partners; and
- f. strengthening the New Zealand Defence Force's core skills.

15. Our role on the United Nations Security Council only increases New Zealand's level of interest in Middle East security issues, including maritime security threats.

Bilateral benefits

16. As demonstrated when we have provided support in the past, New Zealand military contributions would be welcomed by partners in the Middle East and African region. In addition, aircraft and frigate deployments provide secondary defence diplomacy opportunities. New Zealand contributions can also be used as leveraging opportunities by posts, including as a means by which to highlight New Zealand's commitment to regional security.

17. New Zealand military contributions would also be welcomed by our key security partners outside the region. Our partners **s. 9(2)(g)(i)** highly value the experience and the niche capabilities New Zealand can provide.

Planning ahead

18. Previous contributions to maritime security operations have relied, in the first instance, on a request for New Zealand participation in their operations. Others have been organised late and 'tacked' onto an existing deployment (such as when Te Kaha was involved in maritime operations alongside the deployment to attend Anzac Day commemorations earlier this year). This ad hoc approach is not optimal and can result in the New Zealand Defence Force not being able to take advantage of the most suitable opportunities at the best time. It also forces coalition partners to conduct short notice planning to accommodate New Zealand's contributions.

19. The deployment of assets such as an Orion aircraft and frigate require long lead times for coalition planning and to prepare the capabilities for deployment. New Zealand's partners also require advance notice for particular roles such as command of a coalition task force. International forces and commands conducting maritime security operations in the Middle East conduct regular force generation conferences where they identify their projected force needs for upcoming years. Taking a more deliberate and planned approach would allow the New Zealand Defence Force to be more proactive about making offers to contribute personnel and assets and target the most beneficial roles in coalition operations. Therefore Cabinet approval for activities over the next 2.5 years and approval in principle for the following 2.5 years is sought.

Proposed deployments from December 2015 to June 2018

20. Cabinet decisions on an Orion detachment and six staff officer roles are requested from 8 December 2015 to 30 June 2018. Relevant Ministers would be provided with further details in advance of these deployments.

Orion Aircraft Air Surveillance Detachment

21. An Orion is currently based **s. 6(a)** and will return to New Zealand in December 2015. Following regeneration in 2016 it is proposed to be redeployed to the region in 2017. With 5 remaining Orions available for other tasking the proposed Orion deployment is not expected to impact on other outputs.

Logistics support hub s. 6(a)

25. The New Zealand Defence Force has maintained a logistics hub **s. 6(a)** since 2003 to provide support to the various missions and operations deployed to the region. This hub provides a critical enabling role as well as facilitating personnel movements to and from our contributions to the Building Partner Capacity mission in Iraq, the United Nations Truce Supervision Organisation, the Multinational Force and Observers and the current Orion detachment.

26. The mandate for the current deployment of a logistics support hub **s. 6(a)** expires on 30 April 2017 [CAB Min (14) 5/3 refers]. In order to provide continued support to current and proposed future missions in the Middle East region, Cabinet approval is sought to maintain the logistics hub until 30 June 2018. A further extension will be sought beyond that point in line with the later deployments outlined in this paper.

It is therefore recommended that the Minister of Defence in consultation with the Minister of Foreign Affairs may authorise adjustments to the deployments, provided these adjustments do not significantly change numbers, cost or the intent of the mission.

41. Specific and detailed legal issues will be advised to Ministers for any specific deployments such as the Orion aircraft detachments.

⁴ The Logistics Hub is funded until 30 April 2017 [CAB Min (14) 5/3 refers]. The cost of maintaining a Logistics Hub has increased to \$1.292 million per annum (previously \$1.115 million). This is due to both higher demand on accommodation **s. 6(a)** (which has required the New Zealand Defence Force to hire additional facilities) and the reduction in value of the New Zealand dollar to the United States dollar.

Consultation

45. This paper was prepared by the New Zealand Defence Force, the Ministry of Defence and the Ministry of Foreign Affairs and Trade. Treasury was consulted. The Department of the Prime Minister and Cabinet was informed.

Human Rights

46. There are no relevant implications for this paper.

Veterans' Affairs

47. The deployment of New Zealand Defence Force capabilities to multilateral maritime security operations in the Middle East and East African ocean regions has not been declared as qualifying as operational service for the purposes of the Veterans' Support Act 2014. However, military personnel and their families will be able to receive assistance under Accident Compensation Corporation Act 2001 if a military person is harmed or killed during this deployment.

Publicity

48. Previous deployments to maritime security operations in the Middle East have been publicised via a statement from the Minister of Defence. Given sensitivities pertaining to some Middle East countries in the area of operations, statements will need to be coordinated with partner countries. It is recommended that **Out of Scope** **Out of Scope** consideration would be given to an announcement for the Orion and Frigate contribution closer to the time of deployment.

Recommendations:

49. It is recommended that you:

- a. **Note** that New Zealand has a strong strategic interest in the Middle East and Africa, and that the proposed deployments would contribute to New Zealand's broader national security interests, including countering piracy, and countering terrorist attacks and related illegal activities;
- b. **Note** that a more deliberate and planned approach to contributions to maritime security operations would allow the New Zealand Defence Force to be more proactive about making offers to contribute personnel and assets and seek beneficial roles in coalition operations;
- c. **Note** that New Zealand contributions would also be valued by security partners and support bilateral relationships;
- d. **Approve** the deployment of:
 - i. an Orion aircraft air surveillance detachment to the Middle East for a 6-12 month period in 2017;

- e. **Approve** an extension of the logistics support hub **s. 6(a)** **s. 6(a)** from May 2017 to June 2018;

- g. **Agree** that the Minister of Defence and Minister of Foreign Affairs may authorise adjustments to the deployments in response to operational requirements, provided these adjustments do not significantly change numbers, cost or the intent of the mission;
- h. **Approve** the total estimated marginal cost to extend the New Zealand Defence Force commitments to maritime security operations in the Middle East from 8 December 2015 to 30 June 2018 at a total cost of NZ **Out of Scope** as follows:

Operation Takapu – A Royal New Zealand Air Force P-3K2 Orion aircraft has recently played a key role in helping the Combined Maritime Forces seize a large amount of heroin from vessels in the Indian Ocean. Acting on information from the Orion, the first drugs bust involved the seizure of heroin from two vessels by a French ship. This operation seized 400 kilograms of heroin with a street value of \$220 million. The second seizure saw the P-3K2 Orion work with a Royal Australian Navy frigate to intercept a vessel off the Tanzanian coast with some 250 kilograms of heroin seized in this second operation.

The Orion and supporting 55-member detachment are deployed until February 2018.
