Thank you for your Official Information Act request to the Department of Conservation, dated 9 February 2018. You requested information about the kiwi project at Pukaha Forest.

Below is the information you requested:

Please confirm how many Kiwi have been bought in or bred at Pukaha and released into the Pukaha Forest or held in captivity since 2003.

Please confirm the current Kiwi numbers at Pukaha inside the Kiwi House, in fenced enclosures and in the Pukaha Forest.

• There are two kiwi housed in the kiwi house, six kiwi in fenced enclosures and 12 radio-tagged kiwi in Pukaha Forest. This is not the total amount of kiwi in the forest, as not all kiwi are radio-tagged. A selection of kiwi are radio-tagged to monitor trends in success of the wider population at Pukaha Forest.

Please explain why juvenile Kiwi are still released into Pukaha Forest when so many Kiwi have died!

• There have been successes and set-backs with kiwi in Pukaha Forest. It is important to note there were no kiwi deaths in Pukaha Forest in 2017. Predator control methods have been constantly reviewed and refined during the project and new trapping technologies have been introduced to control the predators that threaten kiwi. There is strong support from the community and neighbours to have kiwi in Pukaha Forest and adjoining properties. The community donate their money and time to support this project. It is the combination of strong community support and improving control methods that sees this project continuing.

How much money has been spent on the restoration project by Department of Conservation, the Pukaha Board, Wellington Regional Council & Horizons Regional Council since 2001?

 We can only provide figures for the Department of Conservation and the Pukaha Board back to 2011. Regional councils do predator control on private land surrounding Pukaha Forest. The department does not hold information on money spent by regional councils on private land.
