Thank you for your email of 11 January 2019 to the Ministry of Education requesting the following information:

*I am requesting under the Official Information Act the following information regarding the proposal for a land exchange between the Ministry of Education and the Wellington City Council involving Turnbull Street and Thorndon School land:*

- 1. All email and written correspondence between Ministry of Education officials or their agents and Wellington City Council staff members concerning the land exchange and issues arising written since 1 March 2018.*
- 2. All email and written correspondence between Ministry of Education officials and/ or their agents concerning the land exchange and issues arising written since 1 March 2018.*
- 3. All email and written correspondence between Ministry of Education officials or their agents and the principal or staff at Thorndon School concerning the land exchange and issues arising written since 1 March 2018.*

Your request has been considered under the Official Information Act 1982 (the Act).

#### **Context - land swap to facilitate the creation of a turning head for Thorndon School**

In exchange for their consent to this proposal, objectors requested a permanent public right of way through the Thorndon School site. The Ministry of Education is unable to agree to this as it could impact the school Board's ability to govern and manage its school site, including the obligation to keep students safe. As a result, the proposal has been suspended and is unlikely to proceed.

I am releasing to you 117 emails within scope of your request. The details of the emails and my decision on their release are outlined in the tables attached as **Appendices A, B and C**.

Where information has been withheld it has been done so under the following sections of the Act:

- 9(2)(a), to protect the privacy of natural persons;
- 9(2)(g)(i), to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between the Ministry in the course of their duty;
- 9(2)(h), to maintain legal professional privilege; and
- 9(2)(i), to enable the Ministry to carry out, without prejudice or disadvantage, commercial activities.
