Conversely, island nations such as Haiti have virtually no capacity to plan and respond to natural disasters and consequently suffer devastating damage on a regular basis. OUT OF SCOPE

Seismic activity poses a further risk, with particularly severe events including the 2010 earthquake that devastated Haiti and the 1995 volcanic eruption on Montserrat. OUT OF SCOPE
stands as the lone regional country classified as "low human development". OUT OF SCOPE

The Caribbean region is one of contrasts, ranging from Haiti, the poorest country in the hemisphere through to highly developed, non-ODA eligible countries such as the Bahamas and Cayman Islands. OUT OF SCOPE

Much of
the Caribbean is still seismically active and at risk to volcanic eruptions, most recently the massive eruption on Montserrat's Soufrière Hills volcano, and earthquakes, with the 24 January 2010 earthquake in Haiti being one of the most serious recent events. On a positive side the region is working collectively to monitor seismic activity and engage in effective disaster management planning. The downside is that there is limited capacity within the region to absorb the costs of rebuilding, particularly in countries such as Haiti that seem unluckily prone to such massive catastrophes. ## Overview and Key objectives

The Caribbean Community (CARICOM) is a key regional organisation for the Caribbean, encompassing 14 nations (Antigua and Barbuda, the Bahamas, Barbados, Belize, Dominica, Grenada, Guyana, Haiti, Jamaica, Saint Lucia, Saint Kitts and Nevis, Saint Vincent and the Grenadines, Suriname and Trinidad and Tobago) and one British overseas territory (Montserrat). CARICOM was established in 1973.

The European Development Fund is the main vehicle for EU development assistance to the Caribbean, allocating more than $€ 1$ billion in funding over the 2014-2020 to the Caribbean region through its eleventh round (EDF11). Of this, $€ 420$ million is provided to Haiti. The remaining funding (approximately $€ 580$ million) is provided to regional and bilateral programmes.

## Formal Message: Haiti: Violent Anti-Government Protests

## Summary:

Anti-government protests in Haiti have resulted in nine people dead and a number of people injured since 7 February. Haitian President Jovenel Moise is refusing to accept protesters' demands to resign over allegations of corruption. The Caribbean Community (CARICOM) has released a statement calling for calm. There are four New Zealanders registered in Haiti. CON has notified Safe Travel registrants of the violent protests.

## Action:

## Report:

Since 7 February Haiti has been experiencing violent protests leaving nine people dead and dozens injured. Over the past few days protesters have attacked banks and gas stations, stoned the President's residence and attempted to block road access to the airport in the capital, Port-Au-Prince. On 12 February at least 78 inmates staged a jailbreak from a prison in Aquin, 150 km southwest of Port-Au-Prince.

5 Both the US and Canada have advised their citizens not to travel to Haiti because of the violence. The US has also ordered out all non-emergency US personnel and their families. Canada said it was closing its Embassy due to the "current volatility" but would "continue to assess the situation in the coming days."

- CARICOM Heads of Government met in T\&T in early December to discuss improving the rate of implementation of the CARICOM Single Market and Economy, and ensuring its benefits are more accessible to CARICOM nationals. CARICOM Heads agreed "to move towards full free movement within the next three years". Haiti committed to full integration into the CSME by 2020.


## International

- Twelve of the 15 CARICOM member states issued a statement on 24 January setting out their position of non-interference in relation to the political situation in Venezuela. The Bahamas, Haiti and Guyana were the three CARICOM member states which did not sign the statement. The Bahamas and Haiti announced their recognition of Juan Guaido as Interim President of Venezuela on Thursday afternoon.
