The information you requested - CAS-218016-Q9P5Z4

Thank you for your request for information dated 22 September 2020 about Parking Infringement Notices around Howick College. You asked for the number of offences broken down by offence to include Sandspit Road, Trelawn Place, Reydon Place, Paparoa Road, Bledisloe Street, Rochester Cresent, and Alicia Road for the period 1 January 2019 to 30 September 2020.
