## Your Official Information Act request, reference: GOV-013049

Thank you for your email of 2 August 2021, asking for the following information under the Official Information Act 1982 (the Act):

Can I please have the payment rates for child care accident compensation for the years 2007-2012.

## Our response

Childcare may be paid as social rehabilitation to a client (under section 81 of the Accident Compensation (AC) Act 2001) if:

- the client requires help with childcare because their injury prevents them from undertaking care activities for their child or children; and
- no family, whanau, or other supports can reasonably be expected to provide childcare.

The following four tables contain ACC's rates for childcare; all are shown exclusive of GST.

### Non-contracted childcare rates for social rehabilitation (hourly)

**Contracted childcare services – facility-based (hourly).** These rates were set in 2009, when facility-based and home-based care rates stopped being paid at a single rate, owing to differences in the services provided.

**Non-contracted childcare rates for overnight childcare (per night).** If childcare is required overnight and the carer is someone who doesn't usually live in the client's home, this may be paid as a sleepover.

Childcare may otherwise be paid as part of an accidental death claim (under clauses 76 to 78 of Schedule 1 of the AC Act 2001), because the child's parent died due to an accident.
