There may also be variation in how invoices are completed, which could influence the dates recorded.

 (codes starting with ORT2), and codes related to moonboots. Each service payment is matched to
 the most recent orthotics consultation (codes starting with ORT2) that occurred on or before the
 orthosis was provided, as long as that consultation was within the previous 180 days. The table
 includes the average number of days between the matched consultation and the date the orthosis
 was provided.
