Thank you for your email dated 12 June 2021 requesting under the Official Information Act 1982 (the Act) the following information:

- Could you please provide information on any Kiwibuild homes in Central Auckland and Manukau region planned for the next 3 years, including the ones that have not yet been published on Kiwibuild website.
- Could you please also provide estimated construction start dates and/or estimated construction completion dates for these developments where known.

The table in attachment one outlines KiwiBuild homes built or contracted to be built in the Central Auckland and Manukau areas of Auckland as at 31 May 2021. We have defined Central Auckland as covering the Albert-Eden-Puketāpapa, Maungakiekie-Tāmaki, Ōrākei, and Waitematā and Gulf wards.

Information on KiwiBuild developments that are yet to be announced is withheld under section 9(2)(b)(ii) of the Act as providing this information would be likely to unreasonably prejudice the commercial position of the person who supplied or who is the subject of the information.
