Official Information Act request relating to daily situation reports since 4 September

Thank you for your Official Information Act 1982 (the Act) request received on 1 November 2021. You requested:

Information being released

I have decided to release the relevant parts of the documents listed below, subject to information being withheld as noted.

Some information has been withheld under section 9(2)(a) to protect personal privacy. Further information is withheld under section 6(c) as the release of that information would be likely to prejudice the maintenance of the law, including the prevention, investigation, and detection of offences, and the right to a fair trial. Some other information has been withheld under section 9(2)(b)(ii) as the release of the information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is subject or the information.
