Dear Dr Grahame Craig

I refer to your email of 24 October 2015 in which you request the following under the Official Information Act 1982 (OIA):

"...As the Chair of Trustees of Business Mentors NZ (BMNZ), I wish to be copied with all correspondence to and from MFAT and Ms Kerry Burrige, between the dates of July 1st 2012 and August 31st 2015..."

On 17 November 2015, you agreed to narrow the scope of your request to the following:

"...I can narrow down my request by specifying correspondence containing any one or more of the following keywords:

*Business Mentors NZ
Pacific Business Mentoring Programme
Ray Schofield..."*

On 27 November 2015, you further narrowed the scope to the following:

"...I am prepared to further narrow my request to incoming emails only from Ms Kerry Burrige, which mention Business Mentors New Zealand, the Pacific Mentoring Programme and/or Ray Schofield..."
