Your request for official information, reference: HNZ00036199

Thank you for your email on 16 January 2024, extended 14 February 2024, asking Health New Zealand | Te Whatu Ora for the following under the Official Information Act 1982 (the Act):

"... correspondence from Mr Steve Kirsch received by Te Whatu Ora from 1 September 2023"

Response

The requested emails are enclosed as **Annex One**.

Some information has been withheld under section 9(2)(a) of the Act in order to protect the privacy of individuals. The need to protect their privacy is not outweighed by the public interest in the release of this information.

Some names and email addresses have also been withheld under section 6(d) of the Act, on the basis that making available the information would be likely to endanger the safety of any person.

In addition, Health NZ has withheld correspondence that Mr Kirsch sent to the Employment Relations Authority under s 18(c)(i) of the Act, on the basis that making the information available would be contrary to the provisions of a specified enactment – section 222 of the Employment Relations Act – as it relates to proceedings before the Employment Relations Authority.

Please also find some further information about the related ongoing Court proceedings below:

Orders of Employment Relations Authority

When Health NZ became aware that an employee had unlawfully accessed and shared vaccine related data, we applied for urgent injunctive relief in the Employment Relations Authority.

On 1 December 2023 the Employment Relations Authority granted Orders (the Orders) preventing further sharing of the data and non-publication orders relating to elements of the matter. The Orders restrict all access, use and publication of information held by Health NZ on the National Vaccination Database, or any copies, extracts or information derived from it.

The Orders remain in force and apply to anyone who has obtained, or may obtain, access to or been provided with information from the Database. The Orders prohibit:

 a) disclosing to any third party or publicly releasing any information held by Health NZ on the National Vaccination Database (Database) or any copies, extracts or information derived from it (Information). b) accessing or performing any set of operations on the Information or any copies, extracts or other sets of information derived from the Information, including using, accessing, searching, reviewing, copying, sharing, publishing, making available to any member of the public, transferring or disclosing the Information.

The Orders require anyone who has obtained access to or been provided with information from the Database to delete any and all copies of the Database, any versions of the Information and any other unlawfully obtained information in their possession or control.

Subject: Voluntary removal of PHI from my website

Importance: High

I understand your law firm is attempting to have the obfuscated information taken down.

You don't have any jurisdiction in the US to compel any US firm to do that.

If you think you do, you need to get a new lawyer.

Our investigation thus far has shown that with considerable effort, we believe someone with expert technical knowledge could potentially identify a very small number of individuals, some of these individual deceased. Once our forensic work is complete, we will contact the forest those that could be identified.

In the interest of protecting people's privacy, I am willing to consider individual requests to remove records which you believe match someone's records.

I am not aware of a single record that I published that matches the PHI of any living person. Every field was modified.

If I am mistaken and you can identify any such records, I am happy to redact them if they pose a risk of disclosure or harm to any individual.

Please immediately send me the record IDs of any such record(s) and the reason you believe this is causing harm and I will process your request with urgency.

Also, I wanted to make you aware of this paper published today in the medical peer-reviewed literature. This shows was correct in alerting you to the harms caused by the vaccines. You should be promoting him, not prosecuting him.

As you know, you have **no jurisdiction** over me or my hosting provider. So pissing me off is simply NOT a good idea. It doesn't serve your client well to do that.

I've told Margie Apa that I'd be happy to remove any MRN which discloses PHI.

She ignored my request. I don't get it. If you want to mitigate damages, ignoring my request is stupid.

I suggest you tell them to IMMEDIATELY supply a list of offending MRNs and the NHI number which matches. Will you do that for me?

As far as I know, all the records I published are fully obfuscated so that it is impossible, even for me, to discover the PHI of any person or match the MRN with an NHI.

The records I published do not match the records of any person living or dead. Not a single one. Am I mistaken?

If Health New Zealand disagrees, kindly provide the MRN and the matching NHI identifier.

If you cannot do this, then what's the issue?

I don't want to harm anyone, and I'm happy to VOLUNTARILY redact any offending records, but you have provided NO EVIDENCE OF HARM.

I request that you IMMEDIATELY provide a list of offending MRNs and the associated NHI so that damages can be mitigated.


